Purpose

1. To present to Council the Draft Significance and Engagement Policy 2023 ECM 620629.
2. To seek approval to proceed to consultation on the Draft Significance and Engagement Policy 2023 ECM 620629.

Recommendation

3. That Council:
 - a. receives Report 2022- Draft Significance and Engagement Policy 2023 ECM 620643.
 - b. approves the release for public consultation the Draft Significance and Engagement Policy 2023. Docset 620629.

Executive Summary

4. The South Waikato District Council's Significance and Engagement Policy is a legislative requirement under the Local Government Act 2002 (the LGA) which assists the Council to identify how and when our communities can expect to be engaged or consulted on decisions, issues, proposals, assets and activities.
5. The current Policy was adopted in 2021 (Res 21/155) and is now being reviewed to provide for a more "fit for purpose" document which better reflects and responds to the current challenging economic environment facing Council.
6. Staff have reviewed the Significance and Engagement Policies from other Councils and believe that the Thames Coromandel District Council Policy is more suited to much broader and gives Council some discretion to realise change should the economic environment require it.

Context

7. The usual practice at that South Waikato District Council has been to review the Significance and Engagement Policy as part of the Long Term Plan process every three years. It is due to be reviewed as part of the 2023-24 Long Term Plan process.
8. However, the rapidly changing economic climate has meant that the current Policy no longer assists Council in its decision making.
9. The cost pressures faced by Council include those arising from:
 - Increasing inflation

- Increasing procurement costs
 - Supply chain disruption
 - Labour and contractor shortages
 - Rising operational costs
10. While the overall national inflation rate is 7.2%, some of the costs specifically faced by Council for 2023-24 are increasing at a greater rate. These include:
- Energy Costs by approximately 29%
 - Interest costs by approximately 86%
 - Depreciation by approximately 18%
 - Contract costs by approximately 30%
11. The statement on page two of the Significance and Engagement Policy Item 4: Policy Statements Under assessment of significance item 2) only allows for changes as follows:
- “using the unbudgeted operating expenditure greater than 5 per cent of total operating expenditure in that year, excluding amortisation and depreciation”.***
12. The Local Government Act 2002 – 76AA (4) states that that the Significance and Engagement Policy may be amended from time to time under subsection (1).

The full section is set out below for reference.

76AA Significance and engagement policy

(1) Every local authority must adopt a policy setting out:

(a) that local authority’s general approach to determining the significance of proposals and decisions in relation to issues, assets, and other matters; and (b) any criteria or procedures that are to be used by the local authority in assessing the extent to which issues, proposals, assets, decisions, or activities are significant or may have significant consequences; and

(c) how the local authority will respond to community preferences about engagement on decisions relating to specific issues, assets, or other matters, including the form of consultation that may be desirable; and

(d) how the local authority will engage with communities on other matters.

(2) The purpose of the policy is:

(a) to enable the local authority and its communities to identify the degree of significance attached to particular issues, proposals, assets, decisions, and activities; and

(b) to provide clarity about how and when communities can expect to be engaged in decisions about different issues, assets, or other matters; and

(c) to inform the local authority from the beginning of a decision-making process about—

(i) the extent of any public engagement that is expected before a particular decision is made; and

(ii) the form or type of engagement required.

(3) The policy adopted under subsection (1) must list the assets considered by the local authority to be strategic assets.

(4) A policy adopted under subsection (1) may be amended from time to time.

(5) When adopting or amending a policy under this section, the local authority must consult in accordance with section 82 unless it considers on reasonable grounds that it has sufficient information about community interests and preferences to enable the purpose of the policy to be achieved.

(6) To avoid doubt, section 80 applies when a local authority deviates from this policy

Discussion

13. The currently applicable Significance and Engagement Policy was developed in a time of lower inflation. During the life of the current Long Term Plan, the economic environment has changed considerably.
14. Inflationary impacts are being felt by councils across the country. Other councils, however, have more flexibility in the measures they can take because they are not constrained by a restrictive Policy.
15. For example, some, other Councils Policies are much broader allowing for some discretion to be exercised in decision making, in particular a % or \$ value is not included as a measurement to inform the level of financial significance decision.
16. With a few minor changes, SWDC's policy could be changed to make it better fit to respond to the current environment.
17. To be clear, the changes will still need to be consulted on. That will need to be done in advance of the final decision on the Annual Plan.
18. Without an amendment, the options available for Council's the 2023-24 Annual Plan will be limited. Any changes beyond 5% will need to be made through an amendment to the Long Term Plan. There is now no time for staff to prepare such an amendment.
19. By removing part of the statement in the Significance and Engagement Policy under **Item 4: Policy Statements – assessment of significance item 2)** Council will give itself more flexibility. *“using the unbudgeted operating expenditure greater than 5 per cent of total operating expenditure in that year, excluding amortisation and depreciation”*.
20. While making this change, staff have identified other small textual amendments which could be undertaken to improve the clarity of sentences and reading flow of the Policy.
21. The following headings in the Significance and Engagement Policy are still fit for purpose and staff are recommending no changes.
 - Significance
 - Engagement and Consultation
 - community Engagement
 - Engagement tools and techniques
 - Forms of engagement
 - Engagement process
 - Definitions

Risks

22. If a review and amendment to the Significance and Engagement Policy is not made, the Council will be limited in its options for the Annual Plan and would need to do an amendment to the Long Term Plan.

Options

23. Option 1: Retain the status quo.
This is not viable for the reasons above.
24. Option 2: Amend the status quo other than recommended by staff.
This may be the result of the consultation process. However, staff recommend that an amendment as proposed is consulted on.

25. Option 3: Proceed to consultation on the changes recommended in this report.

Recommendation

- 26. Staff recommend making the changes set out in the appendix to this report and the Draft Significance and Engagement Policy is approved for consultation.
- 27. Staff recommend that the Draft Significance and Engagement Policy is approved for consultation as follows:

Engagement

- 28. There is a statutory requirement to consult with the community under Section 82 of the Local Government Act 2002.
- 29. Given the level of significance, it is recommended that the following consultation occurs:
- 30. It is recommended that the following consultation/ engagement occurs using the normal Communications tactics to promote the Fees and Charges consultation. Items actioned, include website, social, Antenno, posters, flyers and newspaper advertising. A summary document of the key changes will be prepared. In addition, email distribution networks will be used for some targeted messaging to user groups.

Policy Objectives/Ngā Whāinga Kaupapa Here

The objective of this policy is to clarify:

- the degree of significance for proposals and decisions.
- when and how communities can expect to be engaged.

Principles/Ngā Whanonga Pono

South Waikato District Council (Council) will:

- be consistent and transparent in how it engages the public.
- ensure Māori views are considered when engaging.
- consider language, accessibility and cultural needs in any engagement.
- act honestly and openly when analysing and presenting any engagement results.
- provide appropriate information to help people understand what is being proposed.
- prominently outline a proposals or decisions cost in any engagement.

Background/Kupu Tuarongo

Council's Significance and Engagement Policy was last reviewed and adopted in 2021 to meet our legislative requirements under the Local Government Act 2002. The policy:

- enables Council and our communities to understand the significance council places on certain issues, proposals, assets, decisions and activities.
- identifies how and when communities can expect to be engaged or specifically consulted on these items.

The Significance and Engagement Policy applies across our Council. When assessing the degree of significance and deciding on appropriate engagement or consultation processes, the policy requires us to take into consideration other legislative requirements, as well as any other agreements that might already be in place. To ensure Council engages as effectively as possible with the South Waikato District's diverse communities, we gather information on people's views and preferences in a variety of ways. Sometimes that might be via formal statutory consultation, or it might be via a more informal engagement process. Either

way, the overall intent is to ensure that, wherever possible, anyone who wishes to contribute ideas or information to important council processes and decisions has the opportunity to do so.

Policy Statements

Purpose and Scope | Te aronga me te korahi

- 1) To enable Council and its communities to identify the degree of significance attached to particular issues, proposals, assets, decisions and activities.
- 2) To provide clarity about how and when communities can expect to be engaged in decisions made by Council.
- 3) To inform Council from the beginning of a decision-making process about the extent, form and type of engagement required.
- 4) This policy does not apply to decision making under the Resource Management Act 1991 and or other legislation that includes a prescribed consultative/engagement process.

Policy | Kaupapa here

- 1) Engagement with the community helps Council staff to understand the views and preferences of people affected by or interested in a proposal or decision.
- 2) Assessing the significance of proposals and decisions, and the appropriate level of engagement, will be considered in the early stages of a proposal before decision making occurs and, if necessary, reconsidered as a proposal develops.

Assessment of significance | He aromatawai | te pūtake

- 1) Council will consider the following matters when assessing the degree of significance of proposals and decisions, and the appropriate level of engagement:
 - If there is a legal requirement to engage with the community.
 - The level of financial consequences of the proposal or decision.
 - Whether the proposal or decision will affect a large portion of the community.
 - The likely impact on present and future interests of the community.
 - The likely impact on Māori cultural values and their relationship to land and water (reference section 15 LGA 2002).
 - Whether the proposal affects the level of service of a significant activity.
 - Whether community interest is high.
 - Whether the likely consequences are controversial and has a likely impact on the reputation of Council.
 - Whether community views are already known, including the community's preferences about the form of engagement.
 - The form of engagement used in the past for similar proposals and decisions.
- 2) Council will consider the degree to which the issue has a financial impact on Council or the rating levels of its communities.
- 3) If a proposal or decision is affected by one or more of the above considerations, it is likely to have a higher degree of significance.
- 4) In general, the more significant an issue, the greater the need for community engagement.

Engagement and consultation | Tūhonohono me te whakawhiti korero.

- 1) Council will apply a consistent and transparent approach to engagement.
- 2) Council is required to undertake a special consultative procedure as set out in Section 83 of the Local Government Act 2002, or to carry out consultation in accordance with or giving effect to Section 82 of the Local Government Act 2002 on certain matters (regardless of whether they are considered significant as part of this policy).
- 3) For all other issues requiring a decision, Council may determine the appropriate level of engagement on a case by case basis (section 82 of the Local Government Act 2002).
- 4) The Community Engagement Guide (schedule two, attached) identifies the form of engagement Council will use to respond to some specific issues. It also provides examples of types of issues and how and when communities could expect to be engaged in the decision-making process.
- 5) Joint Management Agreements, Memorandum of Understanding or any other similar high-level agreements will be considered as a starting point when engaging with Māori.
- 6) For mana whenua groups without a formal agreement, a separate engagement plan will be developed as appropriate.

- 7) Any decision that is significantly inconsistent with this policy will be dealt with under section 80 of the Local Government Act 2002.

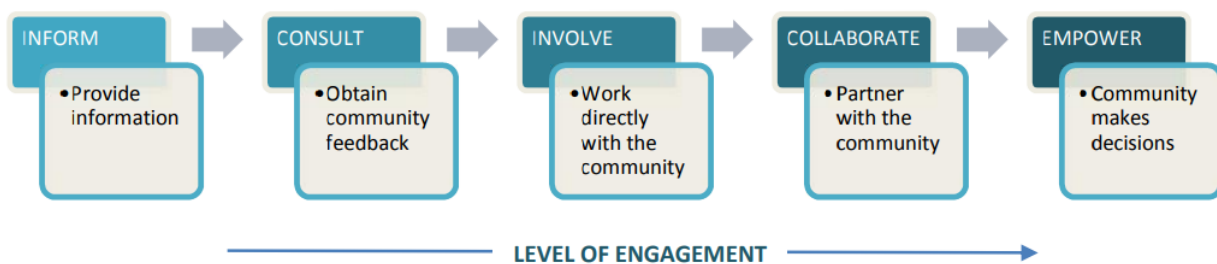
Community engagement/Tūhonohono Hapori

Community engagement is a process involving all or some of the public and is focused on decision-making or problem-solving.

The International Association for Public Participation (IAP2) has developed a Public Participation Spectrum to demonstrate the possible types of engagement with the community. This model also shows the increasing level of public impact as you progress through the spectrum from left to right - 'inform' through to 'empower'. In simply 'informing' stakeholders there is no expectation of receiving feedback, and consequently there is a low level of public impact. At the other end of the spectrum, 'empowering' stakeholders to make decisions implies an increase in expectations and therefore an increased level of public impact. Differing levels of engagement may be required during the varying phases of decision-making on an issue, and for different stakeholders.

It will not always be appropriate or practicable to conduct processes at the 'collaborate' or 'empower' end of the spectrum. Many minor issues will not warrant such an involved approach. Time and money may also limit what is possible on some occasions.

In general, the more significant an issue, the greater the need for community engagement.



When engaging with the community, Council will:

- Seek out and encourage contributions from people who may be affected by or interested in a decision.
- Provide reasonable access to relevant, timely and balanced information so people can contribute in a meaningful way.
- Provide a variety of appropriate ways and opportunities for people to have their say.
- Tell the community what Council's decision is and the reasons for that decision.
- Provide a clear record or description of the relevant decisions made by council and explanatory material relating to the decision.

Engagement tools and techniques/Ngā Keteparaha Mo Ngā Tūhonohono

Over the time of decision making, Council may use a variety of engagement techniques on any issue or proposal and the tools may be adapted based on a range of other factors, including history and public awareness of the issue, stakeholder involvement, and timing related to other events and budgets. Council will also take into consideration other engagements underway, and combined initiatives will be utilised where appropriate to maximise efficiencies and to alleviate 'consultation/engagement fatigue'. Each situation will be assessed on a case-by-case basis.

Forms of engagement/Ngā Tāera Tūhonohono

Council will use the Special Consultative Procedure (as set out in section 83 of the LGA 2002) where required to do so by law, including the following issues requiring decisions:

- Adoption or amendment of the Long-Term Plan (sections 93(2) and 93A).

- Making, amending or revoking a bylaw that Council identifies using this policy as having significant interest to, or significant impact on, the public (section 156(1)(a)).
- The adoption, amendment or revocation of a Local Alcohol Policy.
- The adoption or review of a Local Approved Products (Psychoactive Substances) Policy.
- The adoption or review of a class 4 venue policy under the Gambling Act 2003.
- Adoption of an Annual Plan if the plan is significantly different to the Long Term Plan (section 95(2)).

Unless already explicitly provided for in the Long-Term Plan, Council will seek to amend its Long-Term Plan, and therefore use the Special Consultative Procedure, when it proposes to:

- Significantly alter the intended level of service provision for any significant activity undertaken by or on behalf of Council, including commencing or ceasing such an activity; or
- transfer the ownership or control of strategic assets, as listed in Schedule 1.

Council will consult in accordance with, or using a process or a manner that gives effect to the requirements of, section 82 of the LGA 2002 where required to do so by law, including for the following specific issues requiring decisions:

- Adopting or amendment the annual plan if required under section 95 of the LGA 2002.
- Transferring responsibilities to another local authority under section 17 of the LGA 2002.
- Establishing or becoming a shareholder in a council-controlled organisation.
- Adopting or amending a revenue and financing policy, development contributions policy, financial contributions policy, rates remission policy, rates postponement policy, or a policy on the remission or postponement of rate on Māori freehold land.

For such consultation, Council will follow these principles of consultation (from section 82 of the Act):

- identify people who will or may be affected by, or have an interest in, the decision.
- provide them with reasonable access to relevant information in an appropriate format on the process and scope of the decision.
- encourage people to give their views.
- give people a reasonable opportunity to present their views in an appropriate way.
- listen to, and consider those views, with an open mind; and
- after the decision, provide access to the decision and any other relevant material.

Engagement processes under other Acts

Council is required to engage under other Acts other than the Local Government Act 2002, such as the Resource Management Act 1991 and the Reserve Act 1977. Council will follow the process outlined within the appropriate Act.

For all other issues, the following table provides an example of the differing levels of engagement that might be considered appropriate, the types of tools associated with each level and the timing generally associated with these types of decisions/levels of engagement.

SCHEDULE 1– STRATEGIC ASSETS

WAHANGA 1 – RAWA RAUTAKI

Section 5 of the Local Government Act requires the following to be listed in this Policy:

- a) any asset or group of assets listed in accordance with section 76AA(3) by the local authority; and
- b) any land or building owned by the local authority and required to maintain the local authority's capacity to provide affordable housing as part of its social policy; and
- c) any equity securities held by the local authority in –
 - i. a port company within the meaning of the Port Companies Act 1988.
