THE APPLICATION

Sandra Jamie Maara Metua-O-Takapu GREIG (“the licensee”) applies for an on-site Special Licence in respect of premises situated at 25 Mossop Road, Tokoroa known as the ‘SOUTH WAIKATO SPORTS & EVENTS CENTRE’.

The occasion is a 21st birthday party for Elijah Kingi and up to 220 friends and family are expected to attend.

Substantive food and low alcohol and non-alcoholic beverages will be available at all times.

The day and hours sought are: **Saturday 6 December 2025 4.30pm to 11.00pm**

THE REASONS FOR THE DECISION

The Inspector has provided a report on the application and believes the application meets the criteria for issue.

Neither the Police nor the Medical Officer of Health have raised any matters in opposition.

An exemption is sought from having a certificated manager on duty. This is a relatively large and potentially high risk event. Normally we would require a certificated manager to be on duty managing this event.

We grant the exception but put the licensee on notice that intoxication and minors accessing alcohol must be closely monitored.

Subject to the above, I am satisfied as to the matters to which we must have regard as set out in s.142 of the Act.

DECISION

The District Licensing Committee, pursuant to the Sale and Supply of Alcohol Act 2012 **grants** the application by **Sandra Jamie Maara Metua-O-Takapu GREIG** (“the licensee”) for an on-site Special Licence in respect of premises situated at 25 Mossop Road, Tokoroa known as the **‘SOUTH WAIKATO SPORTS & EVENTS CENTRE’** subject to conditions.

Conditions:

The licence is subject to the following conditions:

The issue of the licence in addition to the prescribed conditions of operation shall be subject to the following discretionary conditions:

1. Alcohol may be sold and supplied for consumption on the premises only on the following days and hours:

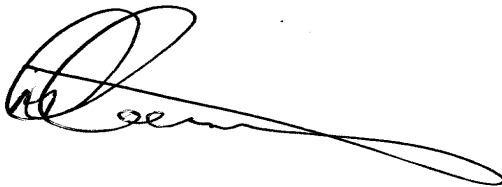
Saturday 6 December 2025 4.30pm to 11.00pm.

2. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
 3. A person nominated by the licensee to be responsible for the conduct of the premises, must be on duty at all times when the premises are open for the sale and supply of alcohol.
 4. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the
-

sample menu supplied with the application for this licence or menu variations of a similar range and standard.

5. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
6. The Licensee must display signage as follows:
 - a. At every point-of-sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
 - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises; and
 - c. A sign prominently displayed at the premises, which identifies by name the for the time being on duty.
7. The licensee must provide information and advice about alternative forms of transport available to patrons from the licensed premises including a courtesy van.
8. No BYO alcohol is to be brought into this event.
