Getting the Most Out of Antenno

ntenno is not just another app – it's your direct line to Council and ensures that you receive important updates about things that directly impact you. Here are some top tips to help you get the most out of this powerful tool.

Stay informed: Enable push notifications to receive real-time updates on important news, events and alerts from Council. From road closures to community events, stay in the loop and never miss out on what's happening in your area.

Choose your places: You can choose the places you want to be alerted about, so we're not bothering you with things that don't affect you. This might include your home, workplace or where your kids go to school. It's customised by you!

Report issues: Spot a pothole, tagging or other maintenance issue in your neighborhood? Use Antenno to quickly and easily report it to Council.

Participate in consultations: Have your say on local projects and initiatives by participating in Council processes through consultation links sent via Antenno.

Save places as specific addresses: There's no need to sift through messages to find what's relevant to you. Antenno provides relevant information for places you care about. So, for example, if there's a water outage on your street you will be notified about it. If something comes up that affects the entire district, you'll also receive a notification. Remember to use your full address, ie, not just Baird Road, Tokoroa; use 37 Baird Road, Tokoroa.

You can opt out of a topic for a specific place: As an example, if you save your work address (where you don't want to receive rates reminders) and your home address (where you DO want to receive rates reminders), you can choose to opt out of receiving rates reminders for your work address. Unfortunately, at this time, you can't opt back in to a topic that you have opted out of.

On time notifications: Just be sure to have your WiFi connection or mobile data on to receive notifications. If you are somewhere without WiFi and don't have your mobile data on, you won't receive new posts until you're connected again.

Choose a nickname: If you have multiple places saved, give each place a nickname. For example - you may add three addresses - Home, Work, Rental Property. Each notification shows which of your saved places it relates to, by displaying the nickname at the top left. You will find that for a State Highway 1 road closure (a district wide message) all three nicknames appear at the top as this post is relevant to all three places. When you receive a notification, first check your nickname as that will indicate which address(es) the message refers to. This is especially relevant with recycling reminders. We've had a few reports of people receiving reminders "on the wrong day" when it turns out that the reminder was for their work address or rental property, not their home address. You can have as many addresses as you want.

Waikato Chamber of Commerce coming to South Waikato

The Waikato Chamber of Commerce will soon expand into the South Waikato. Chamber Chief Executive Don Good said they made the move due to the increase in businesses settling in the district.

"With many more innovative businesses - especially in the forestry, engineering, home construction, social services and education sectors - establishing themselves in Tokoroa and Putāruru, this has created a demand for better connections with regional, national and global companies.

"We have received a great deal of interest from South Waikato businesses [which] are looking to grow and want better connections with regional, national, and global companies.

"In collaboration with the South Waikato Investment Fund Trust, our intention is to initiate, advocacy and lobbying, networking events, social media activity and connections with businesses in the wider Waikato region."

South Waikato Investment Fund Trust Chief Executive Amanda Hema said SWIFT and the Chamber would complement each other.

"SWIFT focuses more on local capability development, and the Chamber provides regional, national and international connections."

To mark the launch, the Chamber, together with SWIFT and Wintec, Toi Ohomai hosted an event in the district. Three Waikato business leaders - David Hallet, co-founder of Hamilton software business Company-X, Tjay Asiata, chief executive of Hamilton-based human resources company LM4 Group, and Gareth van der Heyden, chief executive of poultry business Better Eggs, talked about their business journeys.

The South Waikato has seen significant growth in recent years and has drawn in several big projects, including the Ofi dairy factory, the Putāruru Country

Estate retirement village development and the South Waikato Trades Training Centre Pūkenga Rau.

"One of South Waikato District Council's key strategic goals is to improve the local economy," said Mayor Gary Petley. "I hope our local business leaders connect with the Chamber to take advantage of the support they can offer through their membership programme."

Long Term Plan - coming soon...

Council will soon be consulting with its community on its Long Term Plan 2024-25.

Normally, Council adopts its LTP by 30 June, but we are going to adopt a little later this time in mid-July. This is due to the complexities with Government changes to legislation on the Three Waters Reform. Councils have been given a three-month extension to adopt the LTP. We anticipate that consultation will kick off in early May through to early June.

At the time of writing, staff and Councillors were still crunching the final numbers on what we need to do and how much we can spend.

But we do know a few things.

Like many councils, SWDC is facing a raft of issues like effective delivery of drinking water, dealing with wastewater and draining stormwater (three waters), maintaining aging infrastructure, significant cost escalations and labour shortages.

We know it's hard to talk about the investment that our district needs for the future when the cost of living now is front of everyone's mind.

To make us financially sustainable we have needed to make some tough calls. We started this last year with a higher than previous rates revenue increase, which gave us breathing space to do a full activity and service review. And thank goodness we did because it has put us in a much better position than many other councils.

We have talked before about our under-investment in existing infrastructure. We need to turn that around and you will see through the draft LTP that we will be prioritising three waters renewals and infrastructure.

Council has kept its debt on the low side over the past years. We've shifted our thinking on this. But we should only borrow for the right reasons. Our debt will – and must grow, over the coming decade so that we can invest in our infrastructure that will be available for generations to come (intergenerational equity) and deliver services at a standard our community expects. Unfortunately, this significant investment in the hard-core infrastructure through debt funding means there will be less debt funding available for other projects in order to remain financially responsible.

Despite the challenges that face us, the South Waikato is growing, and we must forge ahead to respond to growth. If we don't invest in our towns, infrastructure and people, our District will go backwards.

We want to see our community thrive. This means creating a robust economy, getting our people into employment (or education), creating more housing opportunities, leaving a sustainable environment for our children and grandchildren and providing opportunity for all to benefit from the district. It's all about striking the right balance.

In the meantime, we are currently open for consultation on our Fees and Charges and key policies. This information is available on our website and summarised on the next four pages of In Touch. We welcome your submissions

FEES & CHARGES





ouncil conducts a full review of its Long Term Plan (LTP) every three years. Typically, we consult on the LTP and all its components simultaneously. However, this year's LTP consultation has been delayed due to the Three Waters Reform. Initially, CONSULTING

Council was required to remove three waters activities from our LTP planning, but now we need to put these activities back on our books.

Several of our Fees and Charges need adopting earlier than what we can now achieve with the full LTP, so we're splitting this component out and consulting now. In addition, several of our policies are ready for consultation, so we're including those now too.

The remaining portions of the LTP – activities, plans, budgets and key areas, will be out for consultation in the coming months.

A GENERAL SHIFT

Most Council services are funded by a combination of fees and charges (when individuals benefit from the particular service) and rates.

We propose several general shifts in our approach to Fees and Charges.

- 1. The Fees and Charges set three years ago in our previous LTP assumed a 2% inflation increase. We all know that inflation is a lot more than that now! So, we've had to increase several fees to keep pace with today's more challenging economic environment.
- 2. We are moving towards recovering costs from those who directly benefit from the service (ie, our Fees and Charges) where it is reasonable to do so. Some of our activities like libraries, pools and other leisure offerings will always require significant rate input. Council needs to balance what is funded by rates and what is funded by those who benefit individually from the service.
- 3. Finally, depreciation must be factored into the charge so that facilities especially can be renewed and replaced.

Several fees are increasing by between 10% and 15%, with some fees lower and/or higher than this. We haven't detailed all the proposed fees in the Consultation Document or here on the next few pages of In Touch, but you can give feedback on any fee – just go to the full document.

ADOPTION

FEES AND CHARGES - PROPOSED CHANGES

LAND INFORMATION MEMORANDUM (LIM)

There has been a moderate increase in fees for LIMs, along with a simplification of fees.

We are discouraging urgent LIMs, which have a three-day turnaround and encourage people to use the standard LIM service (10-day turnaround).

We also used to have different fees for vacant sites versus built sites. We have standardised this into one fee that covers both.

We have also introduced a cancellation fee.

TOKOROA AIRFIELD

We are proposing a new annual landing fee for multiple user/club aircraft and proposing to increase several fees to move towards recovering costs through those who use the facility rather than ratepayers because it is reasonable to do so.

Survey results tell us that most residents want us to explore other options for the airfield and surrounding land. Work is underway for future consideration by Council and the community.

LIBRARY

Library charges are increasing by a small amount to align with the shift to user pays. The good news is that we are removing the fee for overdue books, so no more fines!



FINANCIAL CONTRIBUTIONS

Financial contributions apply across the district except for the Putāruru township which operates under Development Contributions. The formula for charging Financial Contributions sits in the District Plan. As part of its Long Term Plan, Council is reviewing its Development Contributions Policy and this will be ready for consultation alongside the full LTP.

Council is still offering discounted fees in this space to ensure we continue to encourage development and growth.

Only the car parking fee is increasing, the remaining five - roading, reserves, stormwater, water and wastewater, are decreasing to align with the Development Contributions.

By doing this, developers are not disadvantaged based on where they are developing.

RESOURCE MANAGEMENT

There is around a 10% increase in resource consent fees across the fee structure. This is in line with recovering costs through user fees where it is reasonable to do so.

WATER SUPPLY

Metered charges are increasing to ensure appropriate cost recovery for metered users on Council's water supply network.

Over the past years the targeted rate for water supply has increased to keep pace with the cost of providing a safe, healthy and compliant water supply service. Metered charges have not increased by the same amount.

This proposed increase is to restore the equilibrium across all users of the network making it fairer for everyone.

CEMETERIES

Council appreciates that this is a sensitive activity.

Several fees in this area are proposed to increase substantially.

Council's contractor prices have increased in line with these actual costs. Council has only two funding streams to pay for the cemetery service - rates and/or fees. Council's proposal does not burden all ratepayers with the additional cost, but rather increases the fees that are paid by individuals. We know this is an unwelcome increase but we are trying to keep rates as low as possible by shifting costs to those who benefit from the service, where we can and where it is reasonable to do so.

Our proposed fees are comparable with, and in many cases lower than, our neighbouring councils.

Increases are below:


SWIMMING POOLS

Swimming pools is an activity of Council that will likely stay mostly rate-funded. Like libraries and other community facilities, swimming pools contribute significantly to the social fabric of our community and are unlikely to ever be self-supporting. However, we do need to be mindful of the balance between user fees and rates. We are proposing a general increase across all the fees in this space, many less than 5%, but there are some upwards of 10%.

We are proposing higher increases in the hireage space:

- · School usage/hire (per hour) from \$48 to \$60, an increase of 25%.
- Community room parties/functions up to three hours from \$30 to \$40, an increase of 33%

Again, these proposed increases are to have users contribute towards costs where it is reasonable.



DOG CONTROL & REGISTRATION

Dog registration fees are not increasing substantially, while impound and seizure fees have all increased by 10% or more.

The fees that usually attract the most interest from our dog owners are:

Fee	Current	Proposed (2024-25
Standard urban	\$176	\$190
Standard rural	\$77	\$85
Selected Owner (urban only)	\$88	\$90

The Selected Owner fee has traditionally been half of the standard urban fee but is now proposed to be less than half of the standard fee.

This is a great reason to enquire about selected dog ownership and get a property inspection booked in. Call Council on 07 885 0340.

PENSIONER HOUSING

Rents for Pensioner Housing are currently around 55% of market rates. Under our Revenue and Finance Policy this activity is primarily funded by rentals (ie, those who benefit from the service). The cost of servicing and maintaining the Pensioner Housing outweighs the rental income we receive from tenants.

For the 2024-25 year we propose to increase rentals to within 15% of market rates. These increases are reflected below.

Fee	Current	Proposed (2024-25
1-bedroom	\$155	\$225
2-bedroom	\$195	\$305

Rent levels must be set to recover Council's full cost of providing housing to the occupiers. This includes operations, repairs, maintenance and depreciation.

We are also wanting feedback on a possible discount for single people living in twobedroom

SOLID WASTE

Solid waste disposal fees are proposed to change:

- An increase in the standard per tonne fee from \$340 to \$380. The driver for this is that the Government waste levy has increased, and we need to pass on that increase. On the plus side, Council gets waste levy funding back for recycling and waste management initiatives for the community.
- We are increasing our minimum fee from \$5 to \$10. This increase aligns with the actual cost of managing waste and ensuring that those who use the service pay for the service, as opposed to placing the burden on ratepayers.
- The minimum greenwaste fee retained at \$5.

Replacement wheelie bins are both incurring a \$5 increase. We have also introduced some new charges regarding replacement bin lids (at \$15),

replacement wheels (at \$5 per wheel) and replacement axle (\$5). Sometimes bins are placed incorrectly at the kerbside and as a result the truck can damage the bin or parts of the bin. This replacement cost (when it is householder fault) should be borne by the householder, not ratepayer.

> Other fees in this space are proposed to increase by a small amount.

POLICIES - PROPOSED CHANGES

REVENUE & FINANCE POLICY - KEY CHANGES

Removing set percentages - previously, for example the emergency management function would be 100% funded by rates and libraries 92% from rates and 8% from users etc. We have removed all specific percentages and replaced with primary source and secondary source for flexibility.

units.

Operations funded by rates alone - as far as possible operations will not be debt funded. Readers may recall the Annual Plan last year where Council raised that we have historically funded operations in an unsustainable manner. This change addresses this.

We have improved how projects are identified, prioritised and progressed. Only projects that align with our core services will be prioritised and funding options investigated. Rates funding will be a last resort after grants, user charges, debt and depreciation are considered.

Debt funding will only be used for new assets or intergenerational assets, not operations.

Ward rates will be removed, and the cost put on the general rate. This causes minimal impact for ratepayers and is primarily an administrative saving, so more effective and efficient.

Hall rates will be removed, and the cost put on the general rate. Again, the impact is minimal for ratepayers. This change also supports Council's goal to better streamline the number of facilities.

Recycling drop off zones - this targeted rate will be removed and included in the general rate. This charge is not for household collection service, it is for the management and maintenance of the recycling drop off zones.

Additional unit charge has been removed and replaced with a second (third, and subsequent) Uniform Annual General Charge (UAGC). There will be no change in the amount charged, it's just a terminology tidy-up. This only affects properties with additional dwellings.

SIGNIFICANCE & ENGAGEMENT POLICY

The Significance and Engagement Policy provides guidance on how and when Council engages with its community on significant issues, proposals, assets, decisions and activities.

The proposed Policy allows Council to respond to the current challenging economic environment.


Council needs to balance the time it spends on consulting with its community with getting on with the work of delivering our services.

Council can also initiate consultation for projects that don't necessarily meet the Policy guidance.

When faced with the realisation that they cannot handle the responsibility, some pet owners opt for the cruel and irresponsible action of abandoning their pets. This not only puts the animals in grave danger but also strains local animal welfare organisations and shelters.

If you find yourself unable to care for your dog, please do not resort to dumping. Contact Animal Control at 07 885 0340. They are committed to assisting pet owners in distress and will do their utmost to help rehome dogs in need. For cats, reaching out to the SPCA or PAWS is the responsible course of action. These organisations are equipped to provide the necessary care and find new homes for these animals.

An essential step in preventing the overpopulation of pets and, by extension, the abandonment issue, is spaying or neutering your pets. This simple medical procedure not only prevents unwanted litters but also contributes to the health and longevity of your pets. It is a crucial part of responsible pet ownership and a practice that can significantly reduce the number of animals that end up homeless or in shelters.

The surge in pet dumping is a call to action for all of us. It is a reminder of the importance of responsible pet ownership and the need for community support in addressing and preventing this issue. By considering the long-term commitments before adopting a pet, making informed decisions about our ability to care for them and knowing where to turn for help, we can make a difference. Let us come together to ensure that all pets in our community live in safe, loving homes.

Getting Ready for Winter

ith winter fast approaching it's time to start thinking about getting your vehicle ready for the colder weather.

Here are a few things you can do to reduce your chances of a breakdown over winter.

Check your battery

During the winter months your battery will work extra hard with cold starts and the constant use of your car's heater, lights and A/C which all add extra strain. If your car is already having problems, get it checked now. As a backup ensure you have a pair of jumper cables in your boot or even an emergency jump pack.

Check the condition of your tyres

Your vehicles tyres are the only contact you have with the road. Ensure your tyres have at least the legal minimum of 1.5 depth of tread (more is better) and are inflated to the correct pressure. Don't forget to also check the spare tyre.

Clean and check your lights

Check that all your lights, indicators and rear reflectors are clean. Look for blown bulbs or cracked lenses. Also remember to check your lights on full beam as well as any fog lights that may be fitted. Driving with your lights on during the day makes you much more visible in wet and foggy weather.

Wash your windscreen and wipers

Give your windscreen a thorough clean, both inside and out. Also remember to top up your windscreen washer fluid. Check your wiper blades by running your finger down checking for nicks and tears. Check for any chips in the windscreen as these can expand in the cold weather. Remember it's not a good idea to put hot water on a frozen windscreen as it might crack.

Prepare a winter breakdown kit

Ensure it includes a torch, blanket, hi-visibility vest, scraper and snacks. Always ensure your phone is fully charged before leaving on your journey, remember your vehicle battery may go flat leaving you to spend the night in your vehicle.

OUR NITRATES **ARE** WITHIN LEVELS

A recent media statement from Greenpeace sparked a bit of concern in our community, especially from Tokoroa residents.

Greenpeace issued a statement citing that Tokoroa's water contained nitrates, after testing water provided by individuals.

This story led to phone calls from concerned locals and from newspaper reporters.

We want to assure our community:

- Nitrates in the Tokoroa water supply system are well under the maximum levels for Nitrate (N03-N) which is 11.3mg/L.
- Council has been sampling the Tokoroa town water supply since 2007 consistently, all sample results have come back around 4mg/L which is compliant and meets the requirements of the Water Services Regulations.
- Council supplied drinking water across its water supply network is within regulation, according to samples taken by our qualified staff and tested at accredited laboratories.

Special note: Council has no specifics regarding the Greenpeace testing – where and how the samples were taken, if they were collected from tap or source or from private water supplies, nor the method that Greenpeace used to test.
