1. Introduction

The South Waikato District Council makes this Bylaw under Section 22AB of the Land Transport Act 1998.

2. Title

The title of the Bylaw shall be the South Waikato District Council Land Transport Bylaw 2017.

3. Commencement

This bylaw shall come into force after Council resolves to adopt the bylaw and the date of commencement of the bylaw shall be identified in Council's resolution.

4. Interpretation

4.1 Definitions

In this bylaw, unless inconsistent with the context:

Act means the Land Transport Act 1998.

Animal means stock, poultry and any other vertebrate animal of any age or sex that is kept in a state of captivity or is dependent upon human beings for its care and sustenance.

Approved means approved by the Council or by any officer authorised on that behalf by the Council.

Arterial Road means a road described as a Primary or Arterial Secondary Collector road as described by the road classification.

Authorised Agent means any person who is not an employee of the Council but is authorised by the Council to act on its behalf.

Authorised Officer means any person appointed or authorised by the Council to act on its behalf and with its authority including a parking warden appointed by Council under section 7 of the Transport Act 1962 or any Police Officer.

Bicycle includes every bicycle, tricycle, unicycle, velocipede or similar carriage designed to be propelled solely by the muscular energy of the rider, but does not include a wheelchair or similar vehicle.

Bus means a motor vehicle designed solely or principally for the carriage of 13 persons or more, including the driver.

Bylaw means a bylaw of the Council for the time being in force, made under the provisions of any Act or authority enabling the Council to make bylaws.

Council means the South Waikato District Council or any officer authorised to exercise the authority of the Council.

Custodian means any person for the time being appointed by Council to control or manage or to assist in the control and management of any land, building, or premises belonging to or under the jurisdiction of the Council.

Cycle Track of Council means any portion of road on Council land which has been declared as such by a resolution.

Designated means specified by the Council by resolution.

Disabled Person Parking Space means an area reserved for the stopping, standing or parking of disabled persons motor vehicles.

Disabled Persons Motor Vehicle means a parked motor vehicle displaying a Mobility Card issued by the New Zealand Crippled Children Society Incorporated (NZCCS).

District means the district within the jurisdiction and under the control of the Council.

Driver of a vehicle includes any person in charge of the vehicle.

Enforcement Officer means a Police Officer or any other person appointed to carry out any of the duties of an officer.

Footpath means as much of any road or public place that is laid out or constructed by the authority of the Council for pedestrian use. This includes any part of a vehicle crossing or temporary crossing laid out or constructed over a footpath, and edging, kerbing, channelling thereof and any footbridge. (Definition sourced from Land Transport (Road User) Rule 2004).

Goods Service Vehicle means a motor vehicle designed exclusively or principally for the carriage of goods, but does not include a tractor.

Heavy Motor Vehicle means a motor vehicle the gross laden weight of which exceeds 3,500 kg but it excludes vehicles used, kept, or available for the carriage of passengers for hire or reward. (Definition sourced from Land Transport (Road User) Rule 2004).

Intersection has the same meaning as in the Road Transport (Road User) Rule 2004.

Loading Zone means an area of marked roadway designated solely for the purpose of loading or unloading goods or passengers. (Definition sourced from Land Transport (Road User) Rule 2004).

Local Authority means the Council, person, or group of persons authorised by any Act to make bylaws, and which has made this bylaw, and includes the body corporate on behalf of which any such Council, person, or group acts.

Long Term Parking means parking a vehicle on the road for a continuous period exceeding three days.

Mobility Parking Permit means a current Mobility Parking Permit issued by a branch of NZCCS.

Motor Vehicle shall have the meaning assigned to it from time to time by the Land Transport Act 1998.

Network Utility Operator has the meaning set out in section 166 of the Resource Management Act 1991.

Offence includes any act or omission in relation to this bylaw or any part thereof for which any person can be punished either on indictment or by summary process.

Ornamental Grass Verge or Plot includes every flower bed, grass verge or plot, shrubbery or planted area which has been constructed as such and which is separated from the carriageway by kerbing or other well-defined edging.

Parking and Park mean:

- (a) In relation to any road, the stopping or standing of a vehicle for any period exceeding 5 minutes on that road.
- (b) In relation to any other portion of any land or building, the stopping or standing of a vehicle on that portion of land or building.
(Definition sourced from Land Transport (Road User) Rule 2004).
- (c) Other than a vehicle picking up or setting down passengers in a loading zone or reserved parking area, and entitled to do so on that portion of the road zone.

Parking Place means an area of land which the Council has declared to be a place which may be used by the public for the parking of vehicles.

Passenger Service Vehicle means a vehicle used or available for use in a passenger service for the carriage of passengers; but does not include a vehicle specified as an exempt vehicle in Part 2 of Schedule 1 to the Transport Services Act 1989 or in regulations referred to under that Act (Definition sourced from Transport Services Licensing Act 1989).

Person includes a corporation sole and also a body of persons, whether corporate or unincorporated.

Principal Administrative Officer means the principal administrative officer of Council, irrespective of the designation given to that officer, and includes any person for the time being appointed by the Council to perform the duties or a particular duty of the principal administrative officer.

Public Notice shall have the meaning assigned to it from time to time by the Local Government Act 2002.

Public Place means any place that, at any material time, is under the control of the Council and is open to or being used by the public, whether free or on payment of a charge; and includes any road whether or not it is under the control of the Council. It also includes every reserve, park, public carpark, domain, beach, foreshore and recreational grounds under the control of the Council.

Public Work means every activity which the Crown or any Local Authority is authorised to engage in and includes any investigation, enquiry, meeting or item required directly or indirectly for such activity.

Reserve means any land set aside for any public purpose and shall have the same meaning as in the Reserves Act 1977.

Reserved Parking Space means any parking space or parking place which has been reserved by the Council for letting to any person for reserved parking and which is clearly marked by a sign, notice or number or otherwise as being not available for public parking.

Road shall have the same meaning as in the Local Government Act 1974 and shall where the context requires include a street. Road also includes a reference to all or any part of a road and includes:

- (a) A street; and carpark
- (b) A motorway; and
- (c) A place to which the public have access, whether as of right or not; and
- (d) All bridges, culverts, ferries, and fords forming part of a road or street or motorway, or a place referred to in paragraph (c); and
- (e) All sites at which vehicles may be weighed for the purposes of the Land Transport Act 1998 or any other enactment or this bylaw:

Provided that the road is under the control of the South Waikato District Council. (Definition sourced from Land Transport (Road User) Rule 2004).

Road Margin includes any uncultivated margin of a road adjacent to but not forming part of either the roadway or the footpath (if any). (Definition sourced from Land Transport (Road User) Rule 2004).

Roadway means that portion of the road used or reasonably usable for the time being for vehicular traffic in general. (Definition sourced from Land Transport (Road User) Rule 2004).

Special Vehicle Lane means a lane defined by signs or markings as restricted to a specified class of vehicle; and includes a bus lane, transit lane, cycle lane, and a light rail vehicle lane. (Definition sourced from Land Transport (Road User) Rule 2004).

Speed Limit Means the same as in Land Transport Rule: Setting of Speed Limits 2005 which amends the Land Transport Rule: Setting of Speed Limits 2003.

Stock means live farm animals, including, but not limited to, any cow, ox, heifer, steer, calf, sheep, ram, ewe, wether, lamb, goat, kid, boar, sow and pig of any kind.

Stock Movement means to drive, muster, lead or herd livestock along or across the road reserve.

Stock Vehicle means a vehicle that is carrying stock.

Street, Private Road, Footpath and Private Way shall have the respective meanings assigned to them in the Local Government Act 1974 and shall, where the context requires, include a road.

Transit Lane means a lane for the use of the following (unless specifically excluded by a sign installed at the start of the lane):

- (a) passenger service vehicles; or
- (b) motor vehicles carrying not less than the number of persons (including the driver) specified on the sign: or
- (c) cycles; or
- (d) motorcycles; or
- (e) mopeds.

(Definition sourced from Land Transport (Road User) Rule 2004).

Urban Road means any road having a maximum speed limit of no more than 70 kilometres per hour (excluding temporary speed limits).

Urban Traffic Area

Means the same as in Land Transport Rule: Setting of Speed Limits 2005 which amends the Land Transport Rule: Setting of Speed Limits 2003.

Vehicle means a contrivance equipped with wheels, tracks or revolving runners, upon which it moves or is moved but does not include:

- (a) a perambulator or pushchair;
- (b) a shopping or sporting trundler not propelled by mechanical power;
- (c) a wheelbarrow or hand trolley;
- (d) a child's toy or cycle provided in either case no road wheel (including any tyre) has a diameter exceeding 35cm;
- (e) a pedestrian controlled lawn mower;
- (f) any pedestrian controlled agricultural machinery not propelled by mechanical power;
- (g) any article of furniture;
- (h) any invalid wheelchair not propelled by mechanical power;
- (i) a bicycle as defined in this bylaw; or
- (j) any other contrivance specified by the Minister of Transport by notice in the Gazette.
- (k) Any rail vehicle.

(Definition sourced from Land Transport Act 1998).

Waterworks includes all waterworks as defined in Section 5 of the Local Government Act 2002.

Writing, Written or any term of like import means and includes words printed, painted, engraved, lithographed, or otherwise traced or copied.

5. Bylaw Management

Coverage

Words referring to the district, locality, place, person, office, officer, functionary, party, or thing shall be construed distributively as referring to the South Waikato District, locality, place, person, office, officer, functionary, party, or thing, to whom or to which the provision is applicable, related to the South Waikato District.

Headings

The headings to the clauses of this bylaw shall not affect the construction thereof.

Schedules

Every Schedule to this bylaw shall be deemed to form part of this bylaw provided that any such schedule or policy note may be altered from time to time by Council public resolution.

Compliance

For the purposes of this bylaw the word "shall" refers to practices that are mandatory for compliance with this bylaw while the word "should" refers to practices which are advised or recommended.

Officers to continue in office

All officers appointed by the Council under or for the purpose of any repealed bylaw, and holding office at the time of the coming into operation of this bylaw, shall be deemed to have been appointed under this bylaw.

SERVING OF ORDERS AND NOTICES

The Person

There are provisions in this Bylaw that an order may be made upon or a notice may be given to any person requiring them to do or abstain from doing something, or a notice is required to be given or sent to any person. Except where otherwise expressly provided for in any Act, such order or notice shall be delivered to such person, and may be delivered to them either personally or by sending the same, by messenger, post, fax or e-mail, to them at their last-known place or abode or business. If such person is absent from New Zealand the order or notice may be sent to their agent instead of to such person, in any manner mentioned in the last preceding sub-clause.

POWERS OF DELEGATION

In all cases where this bylaw provides for the issue of any order, notice or licence, such order notice or licence shall be deemed to be issued in compliance with this bylaw if the same be issued by any officer of the Council authorised by the Council for that purpose.

Where pursuant to this bylaw any powers or duties are imposed on a Principal Administrative Officer or any authorised officer of the Council that officer may with the consent of the Council delegate any of those powers or duties either generally or particularly to any other officer of the Council.

POWERS OF ENTRY FOR PURPOSES OF THIS BYLAW

The Council shall have for the purpose of doing anything that it is empowered to do under any bylaw, the power to enter for the purpose of inspection, by any authorised officer or an authorised agent, upon:

- (a) Any unoccupied land or building; or
- (b) Any occupied land or building after giving to the occupier thereof, and where practicable to the owner if the owner is not the occupier, 24 hours notice of the intended entry.

Where the occupier is not the owner and notice has not been given to the owner as above, notice of any entry shall be given to the owner as soon as practicable.

In any sudden emergency causing or likely to cause loss of life, injury or damage to the property or any adjoining property, the council may for the purposes of doing anything it is empowered to do under any bylaw, enter, by an authorised officer or an authorised agent, any occupied land or building without giving

prior notice but shall as soon as practicable thereafter inform the occupier, and where the occupier is not the owner, the owner of the land or building.

Every person who obstructs or hinders any such authorised officer or authorised agent in the exercise of their powers hereunder shall be liable to prosecution for an offence against this bylaw.

NOTE – Specific provisions are also provided under other legislations.

DISPENSING POWER

Where in the opinion of the council full compliance with any of the provisions of this bylaw would needlessly or injuriously affect any person, or the course or operation of the business of, or be attended with loss or inconvenience to any person without any corresponding benefit to the community, the council may, on the special application of that person, dispense with the full compliance with the provisions of this bylaw.

Provided that any other terms or conditions (if any) that Council may deem fit to impose shall be complied with by such person, as aforesaid.

FORMS

Wherever throughout this bylaw forms are prescribed, slight deviations therefrom, but to the same effect and not calculated to mislead, shall not vitiate them.

FEES AND CHARGES

The Council may at any time by ordinary resolution, publicly notified, prescribe fees that may be charged in respect of any certificate, authority, approval, consent given, inspection made or service given by the Council under the provisions of the Local Government Act or any other enactment where that enactment contains no provision for authorising the council to charge a fee.

Where any inspection or service for which a fee has been paid (under the provisions of 111.1) has not been given or made, the Council may refund any such fee or portion thereof as it may determine.

OFFENCES AND BREACHES

No person shall do anything or cause any condition to exist for which a licence or approval from the Council is required under this bylaw without first obtaining that licence or approval, and the failure to do so shall constitute a breach of this bylaw.

No application for a licence or authority from the Council, and no payment of or receipt for any fee paid in connection with such application, licence, or authority, shall confer any right, authority, or immunity on the person making such application or payment.

Any person commits a breach of this bylaw who:

- (a) Does, or causes to be done, or knowingly permits or suffers to be done anything whatsoever contrary to or otherwise than as provided by this bylaw; or
- (b) Omits or neglects to do, or knowingly permits or suffers to remain undone, anything which according to the true intent and meaning of this bylaw, ought to be done by them at the time and in the manner therein provided; or
- (c) Does not refrain from doing anything which under this bylaw they are required to abstain from doing; or
- (d) Knowingly permits or suffers any condition of or things to exist contrary to any provision contained in this bylaw; or
- (e) Refuses or neglects to comply with any notice duly given to him/her under this bylaw; or
- (f) Obstructs or hinders any authorised officer of council in the performance of any duty to be discharged by that officer under or in the exercise of any power conferred upon him/her by this bylaw; or
- (g) Fails to comply with any notice or direction given under this bylaw.

And who does not within a reasonable time after notice in writing has been given to them by the Council or any authorised officer of the council, carry out the remedial action specified in that notice.

The notice shall state the time within which the remedial action is to be carried out, and may be extended from time to time by written authority of an authorised officer.

The provisions of this clause shall also apply to any building, part of a building, work, appliance, or material that has, before the coming into force of this bylaw, been constructed, affixed, or provided or omitted contrary to or otherwise than as provided by any provision of any bylaw hereby repealed, but re-enacted, in substance in this bylaw. Notice as aforesaid may be given and renewed in respect of any such building, part of a building, work, appliance or material.

Where it is suspected that any person has committed a breach of this bylaw, that person shall, on the direction of an authorised officer provide his/her full name and address.

PENALTIES FOR BREACH OF BYLAWS

Every person who fails to comply with any part of this bylaw commits an offence and shall be subject to the penalty provisions outlined in section 242 (Penalties for offences) of the Local Government Act 2002.

Pursuant to section 242 of the Local Government Act 2002, for the continuing breach of any bylaw, the Council may apply to the court of competent jurisdiction for an injunction to restrain the further continuance of the breach.

The continued existence of any work or thing in a state contrary to this bylaw shall be deemed a continuing offence within the meaning of this clause.

Note that in relation to Section Four of this Bylaw that the Land Transport (Road User) Rule 2004 creates a number of offences in relation to stopping, standing and parking of vehicles. Without limiting this bylaw, every person commits an offence against this Part of this bylaw, who:

- (a) Fails to comply in all respects with any prohibition, restriction, direction or requirement indicated by the lines, markings, traffic signs and other signs or notices laid down, placed, made or erected on or upon any road, public carpark, reserve or other places controlled by the Council pursuant to any of the provisions of this Part of this bylaw or any resolution made under this Part of this bylaw;
- (b) Fails to comply with any condition, duty or obligation imposed by this Part of this bylaw or by any resolution made under this Part of this bylaw.

Note that in relation to Section 11 of this Bylaw that the Land Transport (Road User) Rule 2004 creates a number of offences in relation to the operation of vehicles on the road. In addition to the Land Transport (Road User) Rule 2004, a person commits an offence against this bylaw who fails to comply with any relevant clauses in Section 11 of this bylaw. A person who commits an offence described in Section 11 of this bylaw can be liable on summary conviction of a fine.

6. General

- 6.1 Words implying the singular include the plural and vice versa.
- 6.2 Any notice, order or other document which is required by this bylaw to be served or given or sent to any person shall be deemed to have been duly served, given or sent if delivered to such person or left at his or her residence or work place or posted to such person to his or her last known address.
- 6.3 Any notice required to be sent or signed by or on behalf of the Council may be sent or signed by any Authorised Officer.
- 6.4 Any resolution of the Council may be amended, rescinded or reinstated by a further resolution of the Council.

7. Parking

(Section 22AB of the Land Transport Act 1998)

Note that Section 7 should be read in association with the schedules and maps as part of this Bylaw.

7.1 Parking and Stopping Restrictions

7.1.1 Council may by resolution publicly notified:

- (a) Prohibit or restrict the stopping, standing or parking of a vehicle of any specified class or description, on a road; or
- (b) Limit the stopping, standing or parking of a vehicle on a road to vehicles of specified class or description; or
- (c) Limit the period of time that a vehicle may park on any part of a road where stopping, standing or parking is limited to such vehicles; or
- (d) Declare any portion of road as time limited for parking in Putaruru or Tokoroa as listed in Schedule Two; or
- (e) Declare any portion of road as parking for disabled persons in Putaruru or Tokoroa as listed in Schedule Three; or

Any such resolution may apply to a specified road or part of a road, or be effective during a specified period of time.

7.1.2 No driver shall, without the prior written permission of the Council, cause or permit a vehicle to be parked in contravention of Section 7.1.1.

7.2 Stopping places for special vehicles

7.2.1 The Council may by publicly notified resolution, reserve and mark out any part of a road as a stopping place or a stand for passenger service vehicles (eg bus or taxi) or for any other specified class of vehicle (eg bicycle stand).

7.2.2 No driver shall, without the prior written permission of the Council, cause or permit a vehicle to be parked in contravention of Section 7.2.1.

7.2.3 The stopping places listed in Schedule 4 Designated taxi Stands, Schedule 5 Designated Bus Stops and Schedule 11 Designated Motorcycle Parking of this Bylaw are hereby deemed to be authorised under 7.2.1.

7.3 Loading Zones

7.3.1 The Council may by publicly notified resolution reserve any part of a road as a loading zone. In any such resolution, the Council may:

- (a) limit the period of time that a vehicle may remain parked in a loading zone; and
- (b) prohibit, restrict or limit the stopping, standing or parking of vehicles other than goods service vehicles in a loading zone.

7.3.2 The loading zones listed in Schedule 1 of this Bylaw, Designated Loading Zones, are deemed to be authorised under 7.3.1.

7.4 Disabled Person Parking Places Reserved

7.4.1 The Council may by publicly notified resolution reserve any part of a road as a parking place for use only by any disabled person(s) whether that person is a passenger in, or the driver of the vehicle.

7.4.2 In a resolution under Clause 7.4.1 the Council may restrict the stopping, standing or parking of vehicles in parking places so reserved, to holders of a mobility-parking permit in accordance with the conditions of issue.

7.4.3 No driver shall cause or permit a vehicle to be parked on any part of a road in contravention of a resolution under Clause 7.4.1 of this bylaw.

7.4.4 The zones listed in Schedule 3 of this Bylaw, Designated Zone: Parking for Disabled Persons are deemed to be authorised under 7.4.1.

7.5 Parking Places Reserved

- 7.5.1 The Council may by publicly notified resolution reserve any part of a road as a parking place, either generally or at specified times, for use only by members of a specified class of persons (including, but not limited to, the judiciary, police, diplomatic corps, medical practitioners and senior citizens).
- 7.5.2 The Council may on application by any person residing in the vicinity of a parking space, grant a permit to that person entitling that person the sole right to park a vehicle in that parking space during such period, and on such conditions, as the Council may determine.
- 7.5.3 No driver shall cause or permit a vehicle to be parked on any part of a road in contravention of a resolution made or permit granted under clauses 7.5.1 and 7.5.2 of this bylaw.

7.6 Method of Parking

- 7.6.1 No driver shall park a vehicle in a parking space so that any part of that vehicle extends beyond any line defining that space.

7.7 Long Term Parking

- 7.7.1 The Council may by publicly notified resolution prohibit long-term parking on any road or part of a road.
- 7.7.2 No driver shall, without the prior written permission of the Council, cause or permit a vehicle to be parked in contravention of Section 7.7.1.

7.8 Parking on Planted Areas, Footpaths, Medians, Traffic Islands

- 7.8.1 Subject to sections 7.8.2 and 7.8.3 no driver shall stop, stand, drive or park a vehicle on that part of the road which is:
- (a) a footpath/walkway/footway/berm; or
 - (b) a grass plot; or
 - (c) a flower bed; or
 - (d) shrubbery; or
 - (e) in respect of an urban road only, the road margin.
- 7.8.2 A person may stop, stand or park a vehicle in contravention of clause 7.8.1 if:
- (a) The vehicle is stopped or standing on an authorised vehicle crossing; or
 - (b) Council has indicated by appropriate signage that vehicles may stop, stand or park in that location; or
 - (c) That person has obtained the prior written permission of the Council to stop, stand or park a vehicle in that location.
- 7.8.3 A person may stop, stand or park a cycle, mobility device, or wheeled recreational device on a footpath if so doing does not unreasonably obstruct any other user of the footpath.

7.9 Standing Vehicles on Roads

- 7.9.1 No driver shall stop, stand or park a vehicle on a road so as to cause an obstruction.
- 7.9.2 No driver shall, without the prior written permission of the Council, park a vehicle on a road for any period exceeding three days, if that vehicle has no effective motive power in or attached to it, or cannot be safely driven. For the purposes of this clause 'vehicle' also includes a trailer.

7.10 Stopping in Service Lanes

- 7.10.1 No driver shall stop, stand or park a vehicle in a service lane so as to cause an obstruction, except for so long as is reasonably necessary to load or unload goods or passengers.

7.11 Displaying Vehicles on Road

- 7.11.1 The Council may by publicly notified resolution prohibit or restrict vehicles being displayed for the purpose of sale, exhibition or demonstration.
- 7.11.2 No driver shall, without the prior written permission of the Council, park a vehicle on an arterial road or road subject to a resolution under Clause 7.11.1 for the purpose of sale, exhibition or demonstration.

7.12 Heavy Motor Vehicle Parking

- 7.12.1 The Council may by publicly notified resolution prohibit heavy motor vehicles from parking on any part of a roadway.
- 7.12.2 No driver of a heavy motor vehicle shall park on that part of a roadway subject to a resolution under Clause 7.12.1 unless the prior written permission from Council has been obtained.

7.13 Off Road Parking

The Council from time to time by public resolution may:

- 7.13.1 Declare any public land or designated parking building to be a parking place thereby making it subject to this bylaw.
- 7.13.2 Where any such land or building has been declared a parking place the signs may provide for the following:
- (a) Fix the number and location of parking spaces in it.
 - (b) Specify the vehicles which shall be permitted to park there.
 - (c) State the days and hours within which parking shall be permitted there.
 - (d) Fix which part or parts shall be available for public use and which part or parts may be available for reserved parking.
 - (e) Fix the fees and rentals payable for parking in or on such land and building.

8. Traffic

(Section 22AB of the Land Transport Act 1998)

8.1 One-Way Roads

- 8.1.1 The Council may from time to time by publicly notified resolution designate a road to be a one-way road or rescind or amend or vary such authorisation from time to time. Note that a one-way road shall apply to all vehicles, other motorised forms of transport, horses and bicycles.
- 8.1.2 Pursuant to Clause 8.1.1 no person shall drive any vehicle or ride any bicycle in any one-way road other than as outlined in the schedules of this bylaw.
- 8.1.3 The roads listed in the Schedule 7 of this bylaw as "One-Way Roads" are hereby deemed to be authorised under 8.1.1.

8.2 Turning Traffic Prohibited

- 8.2.1 The Council may by publicly notified resolution:
- (a) prohibit vehicles from turning to the right or to the left, or turning from facing or travelling in one direction to facing or travelling in the opposite direction at any place or on any road specified in that resolution; and
 - (b) may direct that any such resolution shall apply at all times or only at times specified in the resolution.
- 8.2.2 Pursuant to Clause 8.2.1 no person shall drive any vehicle or ride any bicycle to turn in way other than prescribed in Section 8.2.1.

8.3 Heavy Traffic Restrictions/Prohibitions

- 8.3.1 The Council may by publicly notified resolution prohibit or restrict heavy motor vehicles from a road or part of a road or bridge or limit the gross weight of vehicles on a road or part of a road or bridge or prescribe the routes by which and the times by which heavy motor vehicles may pass over roads.
- 8.3.2 No driver of a heavy motor vehicle shall drive or permit a heavy motor vehicle to be driven on any road contrary to a resolution under Clause 5.3.1 unless:
- (a) that vehicle is used for the express purpose of visiting a property with frontage to a road described in the resolution; or
 - (b) the prior written permission from Council has been obtained.
- 8.3.3 The prohibitions set out in 8.3.1 and 8.3.2 shall not apply to:
- (a) a network utility operator or its authorised agent, or contractor engaged in the provision of, or maintenance of a network utility operation on a road or part of a road.
 - (b) ambulances, fire service vehicles, tradespersons vehicles, campervans or any other class of vehicles that Council may specify from time to time by resolution publicly notified.

8.4 Stock Vehicles Restrictions/Prohibitions

- 8.4.1 The Council may by publicly notified resolution prohibit or restrict stock vehicles from a road or prescribe the routes by which and the times by which stock vehicles may pass over roads.
- 8.4.2 No driver of a stock vehicle shall drive or permit a stock vehicle to be driven on any road contrary to a resolution under Clause 8.4.1 unless the prior written permission from Council has been obtained.

8.5 Road Reserved for Special Vehicles

- 8.5.1 The Council may by publicly notified resolution reserve a road as a special vehicle lane and/or declare any portion of a road a public cycle track for the sole use of bicycles and any mechanical conveyance normally and lawfully used by a disabled person and may alter or vary the width of any track or abolish the same.
- 8.5.2 No driver shall drive a vehicle in a special vehicle lane in contravention of a resolution under Clause 8.5.1
- 8.5.3 The special vehicle lanes or public cycle track listed in Schedule 9 of this bylaw as "Roads reserved for special vehicles" are hereby deemed to be authorised under 8.5.1.

8.6 Restrictions on the Use of Formed, Unformed and Paper Roads

- 8.6.1 Where an authorised officer considers that there is, or is likely to arise at any place on a road, formed or unformed, under the jurisdiction of the Council, a temporary risk of danger to the public or road user or to road workers; or damage to the road, adjoining land and the environment;

That the Council may temporarily restrict the use of, or speed of, a class of vehicles, which may use any part or length of road. Any such restriction shall be defined by the display of temporary warning signs in conformity with the Traffic Regulations 1976.

- 8.6.2 Where a restriction is in place under clause 8.6.1, the Council may require the formulation and implementation of a Traffic Management Plan.

8.7 Road Works

- 8.7.1 Without limiting the Traffic Regulations 1976 and Manual of Transport Signs and Markings Manual (MOTSAM) Part 1 & 2, any vehicle being used for the purpose of maintenance or construction of roading or otherwise, or of any other utility may be driven or parked contrary to any restriction in force under this Part of this bylaw with permission of an authorised officer, provided it is parked or driven with due consideration to other road users.

8.8 Damage to Signs

- 8.8.1 No person shall interfere with, damage or remove any traffic control sign including attaching advertising (sports/garage sales) to existing signs.

9. Other Matters

(Section 145 Local Government Act 2002)

9.1 Leaving Objects on the Road

9.1.1 No person may place or leave objects (including, but not limited to, shipping containers and rubbish skips) on the road unless the prior permission of council is obtained.

9.2 Window Washing and Selling of Goods at Intersections

9.2.2 No person may, without the prior written permission of Council, wash or clean windows or attempt to wash or clean the windows of vehicle or vehicles stopped at any intersection or approach to any intersection.

9.2.3 No person without the prior written permission of Council shall solicit any subscription, collection or donation at any intersection or within 100 metres of the intersection on any of its approaches, or use the intersection for the purposes of selling any goods or services of any kind.

9.3 Public Assembly on Roadway

9.3.1 A person may apply to Council for a permit authorising an assembly, procession, public meeting or demonstration on a roadway.

9.3.2 No person may take part in any assembly, procession, public meeting or demonstration on a roadway, except where Council has issued a permit authorising the assembly, procession, public meeting or demonstration on the roadway, as the case may be.

9.4 Stock

9.4.1 No person, without the prior written permission of Council, may move stock other than in or on a vehicle, on an urban road or an arterial (Primary/Secondary Collector) road. For the purpose of this bylaw any reference to "stock" shall include:

Cattle (Bull, Cow, Ox, Steer, Calf, Heifer); **Horse** (Stallion, Mare, Gelding, Colt, Filly, Ass, Mule or Foal); **Sheep** Ram, Ewe, Hogget, Wether, Lamb **Goat** (Billy, Nanny or Kid); **Deer** (Stag, Doe or Fawn); **Pig** (Boar, Sow or Pig); or any pastoral animal.

9.4.2 Pursuant to Clause 9.4.1 no person shall move stock other than in or on a vehicle, on an urban road or an arterial (Primary/Secondary Collector) road other than as outlined in the schedules of this bylaw.

9.4.3 The roads listed in Schedule 10 of this bylaw as "Stock Routes" are hereby deemed to be authorised under 9.4.1.

9.5 Air Assisted (Jacobs) Brake

9.5.1 No person shall at any time operate or cause or permit to be operated, a Jacobs engine brake or similar device on an urban road.

9.6 Vehicles Over 3,500 kg Prohibited

9.6.1 The Council may by publicly notified resolution restrict or prohibit any vehicle weighing in excess of 3,500kg from being operated on any road or part of a road.

9.6.2 No driver of a vehicle shall drive or permit that vehicle to be driven in contravention of a resolution under Clause 9.6.1. unless:

- (a) that vehicle is used for the express purpose of visiting a property with a frontage to a road described in the resolution; or
- (b) prior written permission from council has been obtained.

9.7 Bona Fide Purposes of Travel

- 9.7.1 No person shall leave any vehicle stationary or unattended on any road other than in connection with the bona fide purposes of travel and stoppages related to travel.

10. Miscellaneous

10.1 Continuation

- 10.1.1 All parking and traffic restrictions and prohibitions in effect as at the date this bylaw comes into effect shall remain in effect.

10.2 Register of Parking and Traffic Resolutions

- 10.2.1 The Council will at all times maintain a Register of Parking and Traffic Resolutions made under this bylaw.

10.3 Application Procedure for Written Permission/ Permit

- 10.3.1 Where this bylaw provides that a person may apply for the prior written permission of Council or obtain a permit from Council, a person may do so by making a written application to the authorised Council Officer.
- 10.3.2 An application made under clause 10.3.1 must be accompanied by a Traffic Management Plan.
- 10.3.3 The Council may grant or refuse the application made under Clause 10.3.1. If the application is granted, Council will issue a permit and may impose reasonable conditions on the use of that permit.

11. Offences

- 11.1 Any person who does or omits, or causes to be done or omitted, any act, or who causes or knowingly permits any condition of things to exist contrary to any of the provisions of this bylaw shall be deemed to have committed a breach of such provisions and on conviction is liable to such penalty as is provided for in Land Transport Act 1998 or where appropriate, the Local Government Act 2002.
- 11.2 Without limiting bylaw 8.1 above in any way or excluding offences specified elsewhere in this bylaw it shall be an offence against this bylaw for any person to do or commit any of the following in a public place unless the approval of Council has been given:
- (a) To cause or permit any vehicle or bicycle to be ridden or driven onto or to stand or rest upon any footpath, ornamental or grass verge or plot laid out in any public place.
 - (b) To obstruct any public place.
 - (c) To park any vehicle which by reason of its condition or contents causes an offensive odour.
 - (d) Move or cause to be moved any vehicle across any footpath or water channel in any public place otherwise than over a crossing properly constructed for such purpose.
 - (e) Stop or park, or permit the stopping or parking of any vehicles at any of the following places or areas:
 - (i) On or immediately adjacent to no-stopping areas indicated by a broken yellow line as listed in Schedule Six.
 - (ii) In a designated loading zone as listed in Schedule One unless the vehicle is a licensed goods service vehicle in the course of its business.
 - (f) Fail or refuse to obey any directional, parking or speed restriction signs or markings in any public place that have been authorised by council by resolution.
 - (g) Drive any type of stock in or along any road within the Tokoroa urban, Putaruru urban, Tirau urban and Arapuni Urban boundaries unless such movement follows a designated Stock Movement Route as listed in Schedule 10.
 - (h) Leave in a parking place a vehicle that is not of the class or classes permitted to use that parking place.

- (i) Leave a vehicle in any space in a parking place during the time it is reserved by the Council for some other person or is not permitted to be used at the time by any vehicle.
 - (j) Leave a vehicle in a parking area except entirely within any lines defining a parking space.
 - (k) Leave a bicycle on a footpath in such a way as to obstruct foot traffic.
- 11.3 No person being the driver or in charge of any vehicle shall stop or stand that vehicle in any service lane, private way or passage vested in or under the control of the Council except for so long as is reasonably necessary to set down or take up passengers or to load or unload that vehicle.
- 11.4 Every application for consent under this part of this bylaw shall be made in writing addressed to the Chief Executive and shall contain all information considered necessary by the Council.
- 11.5 Every consent shall state the name of the person to whom given, the date, place and time when the activity consented to is to be held, performed or erected and other conditions as considered appropriate by Council.

12. Exemptions

- 12.1 The provisions of this bylaw shall not apply to:
- (a) Any vehicle under the control of, or parked, stopped or diverted by the direction of any Traffic Officer, Police Officer or Authorised Officer.
 - (b) Any vehicle at which time is being used by a registered medical practitioner on urgent medical business.
 - (c) Any fire fighting, civil defence vehicle or other rescue vehicle or appliance whilst being used in an emergency.
 - (d) Any vehicle engaged on Council or public work at the place where:
 - (i) No other practicable alternative is available
 - (ii) The vehicle is being used with due consideration for other road users.
 - (iii) The act was reasonably necessary for the purposes of that work.
 - (e) Any vehicle parked, stopped or diverted by an appropriate traffic control sign.
 - (f) A vehicle stopped in a traffic emergency, accident or for other unavoidable cause, for as long as shall be reasonably necessary.

13. Right of appeal

- 13.1 Any person who claims to be unfairly or adversely affected by a decision, order or direction, given by an authorised officer or authorised agent in administering any bylaw may appeal to Council for relief.
- 13.2 The Appeal must be in writing setting out the reasons for the Appeal and must be received by Council within fourteen (14) days after the date on which the decision, order or direction being appealed against was given.
- 13.3 The Council may appoint any standing committee of Council to consider the Appeal and to consider written submissions or submissions delivered in person from the appellant if the committee so decides within 25 working days of the closing date of the receipt of the appeal.
- 13.4 The committee, after considering such evidence and submissions as it thinks necessary, may revoke, confirm, or modify the decision, order, or direction that gave rise to the Appeal.


14. Adoption of Bylaw



Tirau Urban:

- Stock movements through Tirau Township are prohibited.

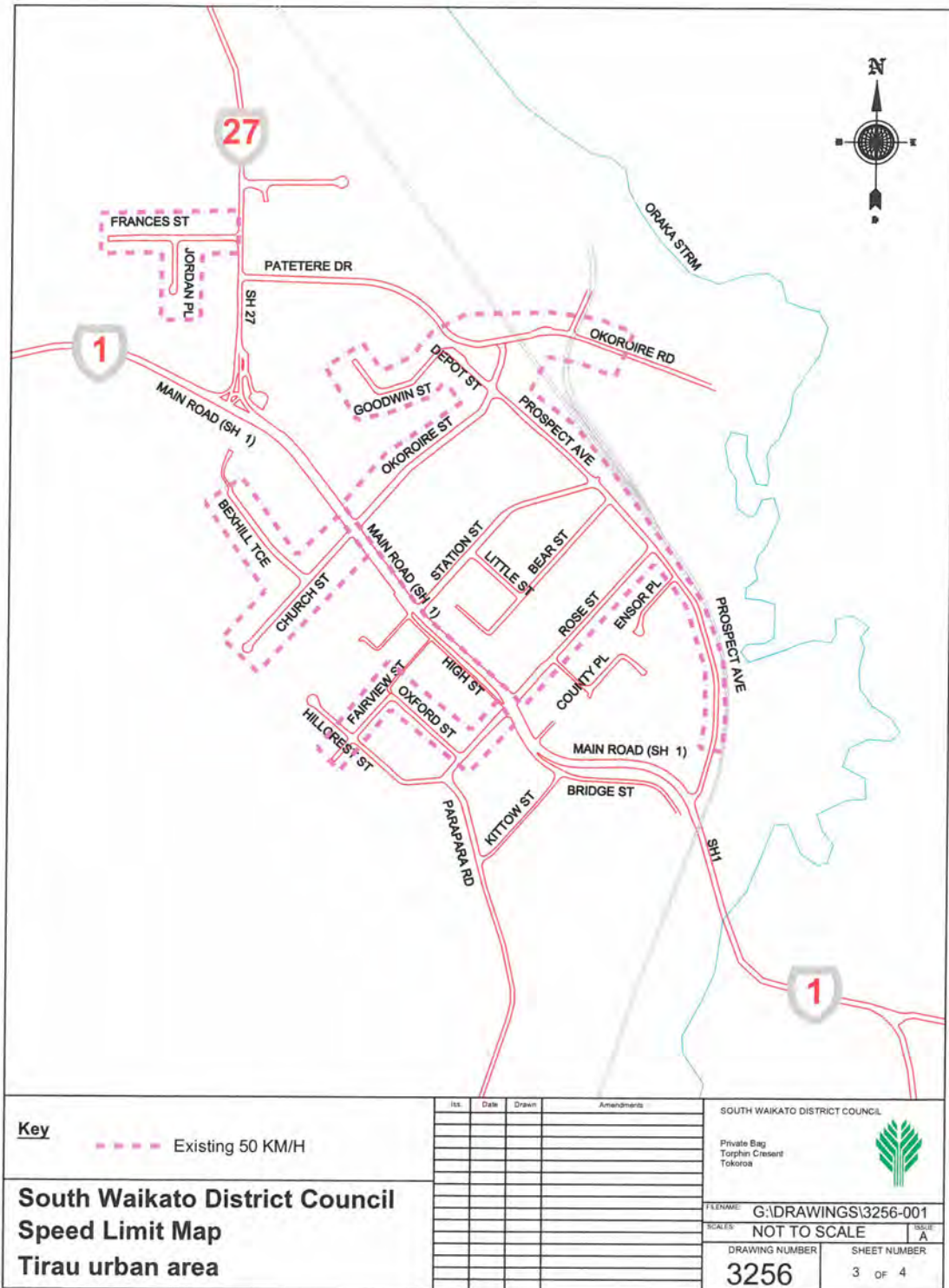
Speed Limit Map – Tokoroa
