## **THE APPLICATION:**

On behalf of Karsin Enterprises Ltd, Delwyn Sines has filed an application pursuant to s.100 of the Sale and Supply of Alcohol Act 2012 for an On-licence in respect of premises situated at 56 Main Street Tirau and known as Alley Cats Café.

The applicant is a company incorporated under the Companies Act 1993 on the  $15^{th}$  day of September 2016.

The business is an established Café.

There will be two certified managers employed.

The applicant seeks the following hours:

Monday to Sunday 10:00am – 10:00pm

The application was publicly notified in the South Waikato News on  $16^{th}$  and  $23^{rd}$  of November 2016. No objections were received.

# **REASONS FOR THE DECISION**

The application is complete and contains all the supporting documents as required under s.100 of the Act. It was duly advertised and no objection, opposition or notice of desire to be heard has been received.

The Licensing Inspector does not oppose this application.

The Police do not oppose this application.

The Medical Officer of Health does not oppose the application.

The Fire Risk Management Officer does not oppose this application.

The premises meets the requirements of the Resource Management Act 1991.

The premise meets the requirements of the Building Code.

The premises currently is "Undesignated". This is appropriate for this type of business.

Currently the South Waikato does not have a Local Alcohol Policy.

Overall I am satisfied as to the matters to which we must have regard as set out in s.105

### **DECISION**

The District Licensing Committee Chairperson, acting pursuant to the Sale and Supply of Alcohol Act 2012, **approves** an application by Delwyn Sines on behalf of Karsin Enterprises Limited for an On-licence (17/ON/009/2016) in respect of premises situated at 56 Main Street, Tirau subject to the following conditions:

### **CONDITIONS**

- 1) No alcohol is to be sold on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1.00pm on Anzac Day to any person who is not present on the premises to dine.
- 2) The following days and hours that alcohol can be sold and consumed on the premises are:
  - Sunday to Monday 10:00am to 10:00pm
- 3) Drinking water is to be freely available whilst the premises are open for business.
- 4) The following steps must be taken to promote the responsible consumption of alcohol:
  - (i) The licensee must ensure that all staff must comply with the host responsibility information submitted with the application for an on-licence detailing the steps to be taken by the licensee to ensure a safe drinking environment.
- 5) The following steps must be taken to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed:
  - (i) Ensure that no intoxicated persons are allowed to enter or to remain on the premises.
  - (ii) Ensure that appropriate signs are prominently displayed detailing the statutory restrictions on the supply of liquor to minors and intoxicated persons adjacent to every point of sale.
- 6) There must be a properly certificated manager or duly appointed manager on the premises at all times the premises is open for the sale and supply of alcohol
- 7) The entire area is "Undesignated".
