THE APPLICATION:

Chrsi Rollitt has filed an application on behalf of Putāruru Hotel Limited pursuant to s.127 of the Sale and Supply of Alcohol Act 2012 for an On-licence renewal in respect of the premises situated at 79 Princes Street Putāruru and known as Putāruru Hotel Te Waihou Bistro (The Cook Putāruru).

The applicant is a company incorporated under the Companies Act 1993 on the 5th day of June 2014.

The business is an established Hotel and Restaurant.

There will be four certified managers employed on the premises

The applicant seeks the following hours:

Sunday to Tuesday 11.00 am to 10.00 pm

Te Waihou Bistro (The Cook Putāruru) Al Fresco Dining (front grassed area) Meeting/Breakfast Room

Wednesday to Saturday 11.00 am to 11.00 pm

Te Waihou Bistro Al Fresco Dining (front grassed area) Meeting/Breakfast Room

Monday to Sunday 11.00 am to 1.00 am the following day

Hotel Entrance/Foyer

Conference/Function Room & House Bar

The application was publicly notified in the South Waikato News on the 3rd of February 2016 & 10th of February 2016. No objections were received.

REASONS FOR THE DECISION

The application is complete and contains all the supporting documents as required under s.127 of the Act.

When considering the criteria for the renewal of licenses as contained within Section 131 of the Act, the Committee must have regard to a number of issues. These include;

- (i) Purpose and Object of Act
- (ii) Suitability of the applicant
- (iii) Other information considered in respect to criteria in section 131 of the Act;

In deciding whether to renew a licence, the licensing committee concerned must have regard to the following matters:

- I. the matters set out in paragraphs (a) to (g), (j), and (k) of section 105(1):
- II. whether (in its opinion) the amenity and good order of the locality would be likely to be increased, by more than a minor extent, by the effects of a refusal to renew the licence:
- III. any matters dealt with in any report from the Police, an Inspector, or a Medical Officer of Health made by virtue of section 129:
- IV. the manner in which the applicant has sold (or, as the case may be, sold and supplied), displayed, advertised, or promoted alcohol.

The Inspectors report is both comprehensive and positive.

There is no question as to the suitability of the applicant.

There is nothing in that report to suggest that the applicant has managed the Sale and Supply of Alcohol in an inappropriate manner during the currency of the Off-licence.

In this matter I believe that the criteria under Section 131 of the Act have generally been met given that:

- (i) The Inspector has provided a positive report,
- (ii) The relevant agencies have not objected to this application;
- (iii) The application has drawn No Objection from the public,
- (iv) The applicant has managed the Sale and Supply of alcohol appropriately during the currency of the licence.
- The Licensing Inspector does not oppose this application;
- Neither the Police nor the Medical Officer of Health have objected to this application;
- The Fire Risk Management Officer does not oppose this application;
- The premises meets the requirements of the Resource Management Act 1991;
- The premises meets the requirements of the Building Code;
- The premises is "undesignated", this is appropriate for this type of business;
- Currently the South Waikato does not have a Local Alcohol Policy.

Overall I am satisfied as to the matters to which we must have regard as set out in s.105 and s. 131 of the Act.

DECISION

The District Licensing Committee Chairperson, acting pursuant to the Sale and Supply of Alcohol Act 2012, **approves** an application Putāruru Hotel Limited for an On-licence renewal (17/ON/015/2014) in respect of premises situated at 79-83 Princes Street Putaruru and known as Putāruru Hotel Te Waihou Bistro (The Cook Putāruru) subject to the following conditions:

CONDITIONS

- 1) No alcohol is to be sold on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1.00pm on Anzac Day to any person who is not present on the premises to dine.
- 2) The following days and hours that alcohol can be sold and consumed on the premises are:

Sunday to Tuesday

11.00 am to 10.00 pm

Te Waihou Bistro (The Cook Putāruru) Al Fresco Dining (front grassed area) Meeting/Breakfast Room

Wednesday to Saturday

11.00 am to 11.00 pm

Te Waihou Bistro Al Fresco Dining (front grassed area) Meeting/Breakfast Room

Monday to Sunday

11.00 am to 1.00 am the following day

Hotel Entrance/Foyer Conference/Function Room & House Bar

- 3) Drinking water is to be freely available whilst the premises are open for business;
- 4) The following steps must be taken to promote the responsible consumption of alcohol;
 - (i) The licensee must ensure that all staff must comply with the host responsibility information submitted with the application for an on-licence detailing the steps to be taken by the licensee to ensure a safe drinking environment;
- 5) The following steps must be taken to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed;
 - (i) Ensure that no intoxicated persons are allowed to enter or to remain on the premises.
 - (ii) Ensure that appropriate signs are prominently displayed detailing the statutory restrictions on the supply of liquor to minors and intoxicated persons adjacent to every point of sale.
- 6) There must be a properly certificated manager or duly appointed manager on the premises at all times the premises is open for the sale and supply of alcohol
- 7) The house bar is designated "Restricted".
- 8) All remaining areas are "Undesignated".
