The Licensing Inspector Ms Kristina Moore reports that there have been minor issues in the past with the Club and their licence however these matters were resolved and no matters have come to her attention since these matters were resolved. The Licensing Inspector does not oppose this application.

The entire premise is to be designated as a "Supervised" area for both events. After 9pm the entire premises be designated as a "Restricted" area for the Birthday celebration

The entire premises be designated as a "Restricted" area for the "Farmers Welcome In Dinner" event

The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.

Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol.

A certificated manager must be on duty at all times when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed at/in the premises.

The licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises.

The premises must be vacated within 30 minutes of the stated finishing time.
