IN THE MATTER of an application by Frank Syben on behalf of the Tokoroa Street Rodders Inc pursuant to s138 and s142 of The Act for an On Site Special Licence in respect of premises situated 51 Moffat Road Crescent Tokoroa known as Tokoroa Association Football Club.

THE APPLICATION

- 1) Frank Syben on behalf of the Tokoroa Street Rodders Inc applies for an on-site Special Licence in respect of premises situated at 51 Moffat Road Tokoroa.
 - 2) The application is for two planned events to be held at the Tokoroa Airport. The first on the 3rd of December 2016 (with an alternative weather day of the 4th of December 2016), the second event is to be held on the 25th of February 2017.
 - 3) The applicant has advised that a meal will be provided for both events, this will consist of a BBQ type dinner.
 - 4) Alcohol will be sold from the bar and consumed within the clubrooms for the event.
 - 5) The applicant's representative Mr Frank Syben has advised that there will be six staff present during the evening including himself. They will be on duty throughout the evening to assist with monitoring and surveillance during the event.

- 1) The applicant has provided information that the event will have low alcohol and non-alcoholic refreshments provided. Drinking water will be available from the bar or freely available from the kitchen.
 - 2) The applicant has advised that staff can call taxis for patrons if required. There is also signage with the number of the local taxi if alternative transport arrangements need to be made.

REASONS FOR THE DECISION

- 3) Tokoroa Street Rodders Inc Club has previously operated special licences with no issues and is a responsible organisation.
- 4) The comprehensive report of the Inspector indicates that the amenity and good order of the locality will not be adversely affected by more than a minor extent.
- 5) Food, non alcohol and low alcohol refreshments and free water will be available throughout both events.
- 6) The application was not required to be publicly notified and no opposition or notice of desire to be heard has been received. Accordingly I deal with the matter on the papers.
- 7) Neither the Police nor the Medical Officer of Health raises any matters in opposition.
- 8) The South Waikato District Council does not currently have a Local Alcohol Policy.
- 9) I am satisfied as to the matters to which we must have regard as set out in s. 105 & 142 of the Act.
- 10) Substantive food and free water will be available throughout the event.
- 11) I am satisfied as to the matters to which we must have regard as set out in s105 & s142 of the Act.

DECISION

- 12) The District Licensing Committee Chairperson, acting pursuant to the Sale and Supply of Alcohol Act 2012 grants the application by Mr Frank Syben on behalf of the Tokoroa Street Rodders Inc for an on-site Special Licence 17/SP/063/2016 in respect of premises situated at 51 Moffat Road Tokoroa, known as the Street Rodders Clubrooms with the following conditions.

CONDITIONS

- 13) Alcohol may be sold and supplied under the licence only on the following day and during the following hours:
 - **Saturday 3rd November 2016 from 4:00pm – 11:00pm the same day.**
 - **(alternative day Sunday 4th November 2016 – Same Times)**
 - **Saturday 25th of February 2017 from 4.00pm – 11.30pm the same day.**
- 1) The proposed designation for the event is as follows - That the premises are "Undesignated" between 4.00pm to 9.00pm and "Restricted" from 9.00pm to 11:00pm.
- 2) The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.

- 3) Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
- 4) Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol.
- 5) The licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises.
- 6) The premises must be vacated within 30 minutes of the stated finishing time unless an individual's presence on the premises is justifiable pursuant to Section 255(4) of the Sale and Supply of Alcohol act 2012.
