The Applicant

- 1. Katrina Ensor on behalf of the Putaruru Bowling Club applies for an on-site Special Licence in respect of the premises situated at 82 Arapuni Street Putaruru and known as the Putaruru Bowling Club.
- 2. The application is to covers Business House Bowls on every Tuesday evening commencing 8th November 2016 and concluding 28th February 2017.
- 3. The specified times will be 5.30pm until 9.30pm on the evenings stated.
- 4. The applicant has stated that meals will be provided during the specified times by way of a BBQ type meal.
- 5. Alcohol will be sold from the bar and consumed within the club room for the event.
- 6. The applicant has provided information that the event will have low alcohol and non from the bar alcoholic refreshments provided. Drinking water will be available at all times.
- 7. The applicant has advised that she and at least 4 staff will be present during the event, this includes two certified managers. Mr Graham Peter Motion and Mr Russell Ensor.

Reasons for the Decision

- 1. Putaruru Bowling Club have previously operated special licences with no issues and is a responsible organisation.
- 2. The comprehensive report from the inspector indicates that the amenity and good order of the locality will not be adversely affected by more than a minor event.
- 3. Food, non alcoholic refreshments and free water will be available throughout the events.
