### THE APPLICATION

Wesley Ah Chan has filed an application on behalf of Lance William Kennett pursuant to s.100 of the Sale and Supply of Alcohol Act 2012 for an Off Licence (17/OFF/002/2016) in respect to the premises situated as 6581 SH1 Atiamuri and known as The Bull Ring Bottlestore.

The premises, known as Bull Ring Bottelstore, is situated on a 7150.0m<sup>2</sup> rural property on the eastern side of State Highway 1, Atiamuri. The building includes a small convenience shop, tavern/restaurant, café/tearooms, liquor store, as well as backpackers' accommodation, which is a standalone building to the north of the main building. The Bottlestore is the subject of this application.

The premises has held an Off Licence since at least 1998.

There is one certified manager currently with the Bull Ring Bottlestore Mr Lance William Kennett.

Mr Kennett's partner Ms Paradee Harnsungnoen has recently made application for a Managers Certificate with South Waikato District Council to enable her to assist Mr Kennett in the running of both the Tavern/Restaurant and the Bottlestore.

The Inspector has provided a positive report and has recommended the granting of an Off Licence.

Both the Medical Officer of Health and New Zealand Police have reported without opposition to the application.

The proposed use of the premises meets the requirements under the resource management Act 1991 in respect to the Sale and Supply of Alcohol Act 2012 s.11(f).

The proposed use of the premises complies with the Building Code in respect to the Sale and Supply of Alcohol Act 2012 s.11(f).

The Fire Risk Management Officer has reported, without opposition to the application.

The application was duly advertised and did not attract any public objection.

The South Waikato District Council does not currently have a relevant Local Alcohol Policy.

#### **COMMITTEE DECISION AND REASONS**

- 1) The purpose of the Sale and Supply of Alcohol Act 2012 (the Act) is to put in place a system of control over the sale and supply of alcohol (s3). The object of the Act is to ensure that the sale and supply of alcohol is undertaken safely and responsibly and the harm caused by excessive or inappropriate consumption of alcohol is minimised (s4).
- 2) In deciding whether to issue a licence the District Licensing Chairperson must have regard to the criteria in s105. The Chairperson must consider the following questions:
- a) Does the grant of the licence ensure the safe and responsible supply of alcohol and the minimisation of harm caused by excessive or inappropriate use of alcohol?
- b) Is the applicant suitable?
- c) Are the days and hours during which the applicant proposes to sell alcohol suitable?
- d) Is the design and layout of the premises suitable?
- e) Does the applicant propose to sell goods other than alcohol such as low-alcohol refreshments, non-alcoholic refreshments and food?
- f) Does the applicant propose to provide services other than those related to the sale of alcohol, low-alcohol refreshments, non-alcoholic refreshments and food?
- g) Will the amenity and good order of the locality be reduced to more than a minor extent by the effects of the issue of the license? Is the amenity and good order of the locality already so badly affected by the effects of the existing licenses that it is unlikely to be reduced further by the effects of the issue of the license, or is it desirable not to issue any further licenses?
- h) Does the applicant have appropriate systems, staff and training to comply with the law?
- i) Have the police or medical officer of health raised any concerns?
  - 3) The Inspectors report is both comprehensive and positive. It covers the matters required including Amenity and Good Order. The Inspector reports that there is no reason to believe that the amenity and good order of the locality would be likely to be increased, to more than a minor extent, by the effects of a refusal to renew the licence.
  - 4) I am satisfied as to the matters to which I must have regard and I am satisfied that the application generally meets the Purpose and Object of the Act. Accordingly, I grant the Off Licence with the agreed hours as above and with the conditions listed below.

# **CONDITIONS**

This licence is subject to the following conditions:

1. Alcohol may be sold on, or from, the premises for consumption off the premises, and supplied free as a sample for consumption on the premises, only on the following days and hours:

### MONDAY TO SUNDAY 8.30AM - 10:00PM

- 2. No alcohol is to be sold or delivered from the premises on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day:
- 3. While alcohol is being supplied free as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied
- A certificated manager or duly appointed Acting or Temporary Manager must be on duty within the licensed area at all times when the premises are open for the sale and supply of alcohol;
- 5. The Licensee must display signage as follows:
  - At every point of sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
  - A copy of the licence attached to the premises so as to be easily read by persons attending the premises; and
  - A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty.
- 6. The whole of the premises is designated as a supervised area

### **CONCLUSION**

The Off Licence application (17/OFF/002/2016) filed by Wesley Ah Chan on behalf of Lance William Kennett for the premises situated at 6581 SH1, Atiamuri and known as Bull Ring Bottlestore is granted subject to the conditions set out above and for a period of one year.

The Licence may be issued immediately.
