IN THE MATTER of the Sale and Supply of Alcohol Act 2012 (The Act)

AND

IN THE MATTER of an application by Liam Lancaster on behalf of the Tokoroa Association Football Club pursuant to s138 and s142 of The Act for an On Site Special Licence in respect of premises situated 19 Benalder Crescent Tokoroa known as Tokoroa Association Football Club.

BEFORE THE SOUTH WAIKATO DISTRICT LICENCING COMMITTEE CHAIRPERSON

THE APPLICATION

Liam Lancaster on behalf of the Tokoroa Association Football Club applies for an on-site Special Licence in respect of premises situated at 19 Benalder Crescent Tokoroa and known as Tokoroa Association Football Club.

The event is for the end of year Prizegiving of the Tokoroa Association Football Club on Saturday 8th October 2016 from 6:00pm to 1:00am the following day.

The Club currently holds a Club Licence with the licensed hours being:

Monday to Thursday 6.00 pm to 10.00 pm
Friday to Saturday 11.00 am to 12.00 midnight
Sunday 11.00 am to 10.00 pm

The applicant has advised that a variety of foods will be available throughout the evening such as, sausage rolls, savouries, sandwiches and pizza.

Alcohol will be sold from the bar and consumed within the clubrooms for the event.

The applicant's representative Mr Liam Lancaster has advised that there will be four staff present during the evening including himself as duty manager. They will be on duty throughout the evening to assist with monitoring and surveillance during the event.

The applicant has provided information that the event will have low alcohol and non-alcoholic refreshments provided. Drinking water will be available from the bar or freely available from the kitchen.

The premises are currently "Undesignated" under the Club Licence.

The applicant has advised that staff can call taxis for patrons if required. There is also signage with the number of the local taxi if alternative transport arrangements need to be made.

REASONS FOR THE DECISION

Tokoroa Association Football Club has previously operated special licences with no issues and is a responsible organisation.

The comprehensive report of the Inspector indicates that the amenity and good order of the locality will not be adversely affected by more than a minor extent.

Food, non-alcohol and low alcohol refreshments and free water will be available throughout both events.

The application was not required to be publicly notified and no opposition or notice of desire to be heard has been received. Accordingly I deal with the matter on the papers.

Neither the Police nor the Medical Officer of Health raises any matters in opposition.

The South Waikato District Council does not currently have a Local Alcohol Policy.

I am satisfied as to the matters to which we must have regard as set out in s. 105 & 142 of the Act.

Substantive food and free water will be available throughout the event.

The comprehensive report of the Inspector indicates that the amenity and good order of the locality will not be adversely affected by more than a minor extent.

I am satisfied as to the matters to which we must have regard as set out in s105 & s142 of the Act.

DECISION

The District Licensing Committee Chairperson, acting pursuant to the Sale and Supply of Alcohol Act 2012 grants the application by Mr Liam Lancaster on behalf of the Tokoroa Association Football Club for an on-site Special Licence 17/SP/062/2016 in respect of premises situated at 19 Benalder Crescent Tokoroa known as Tokoroa Association Football Club subject to the following conditions.

CONDITIONS

- 1) Alcohol may be sold and supplied under the licence only on the following day and during the following hours:
 - **Saturday 8th October 2016 from 6:00pm – 1:00am the following day.**
- 1) The proposed designation for the event is as follows - That the premises are "Undesignated" between 6.00pm to 10.00pm and "Restricted" from 10.00pm to 1:00am (the following day).
- 2) The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
- 3) Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
- 4) Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol.

- 5) The licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises.
- 6) The premises must be vacated within 30 minutes of the stated finishing time unless an individual's presence on the premises is justifiable pursuant to Section 255(4) of the Sale and Supply of Alcohol act 2012.
