THE APPLICATION:

On behalf of Attari Hospitality Limited, Kuljinder Singh has filed an application pursuant to s.100 of the Sale and Supply of Alcohol Act 2012 for an On-licence in respect of premises situated at 79 Princes Street, Putāruru and known as Putāruru Hotel Public Bar.

The applicant is a company incorporated under the Companies Act 1993 on the 3rd of August 2016.

The business is an established Tavern.

There will be four certified managers employed.

The applicant seeks the following hours:

Monday to Saturday 9:00am - 1:00am (the following day)

• Sunday 9:00am - 10:00pm

The application was publicly notified in the South Waikato News on 11th & 18th of January 2017.

REASONS FOR THE DECISION

The application is complete and contains all the supporting documents as required under s.100 of the Act. It was duly advertised and no objection, opposition or notice of desire to be heard has been received.

The Licensing Inspector does not oppose this application.

The Police do not oppose this application.

The Medical Officer of Health does not oppose the application.

The Fire Risk Management Officer does not oppose this application.

The premises meets the requirements of the Resource Management Act 1991.

The premise meets the requirements of the Building Code.

The premises is designated "Restricted" this is appropriate for this type of business.

Currently the South Waikato does not have a Local Alcohol Policy.

The applicant duly advertised their intention to renew their Off-licence.

The application did not attract any public objections.

Overall I am satisfied as to the matters to which we must have regard as set out in s.105

DECISION

The District Licensing Committee Chairperson, acting pursuant to the Sale and Supply of Alcohol Act 2012, **approves** an application by Kuljinder Singh on behalf of Attari Hospitality Limited for an On-licence (17/ON/010/2016) in respect of premises situated at 79 Princes Street, Putaruru subject to the following conditions:

CONDITIONS

- 1) No alcohol is to be sold on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1.00pm on Anzac Day to any person who is not present on the premises to dine.
- 2) The following days and hours that alcohol can be sold and consumed on the premises are:

Monday to Saturday 9:00am - 1:00am (the following day)

Sunday 9:00am - 10:00pm

- 3) Drinking water is to be freely available whilst the premises are open for business.
- 4) The following steps must be taken to promote the responsible consumption of alcohol:
 - (i) The licensee must ensure that all staff must comply with the host responsibility information submitted with the application for an on-licence detailing the steps to be taken by the licensee to ensure a safe drinking environment.
- 5) The following steps must be taken to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed:
 - (i) Ensure that no intoxicated persons are allowed to enter or to remain on the premises.
 - (ii) Ensure that appropriate signs are prominently displayed detailing the statutory restrictions on the supply of liquor to minors and intoxicated persons adjacent to every point of sale.
- 6) There must be a properly certificated manager or duly appointed manager on the premises at all times the premises is open for the sale and supply of alcohol
- 7) A duty manager register pursuant to Section 232 must be kept on the premises and maintained.
- 8) The licence is issued for one year and can be issued immediately.
