

APPLICATION 17/ON/015/2017
IN THE MATTER of the Sale and Supply of Alcohol Act 2012(The Act)
AND
THE MATTER OF an application by H&H Putāruru Limited Limited pursuant to s100 of the Act for an On-licence in respect of premises situated at 57-61 Tirau Street, Putaruru and known as Hog & Hounds Sports Bar.

THE APPLICATION:

H&H Putāruru Limited has filed an application pursuant to s.100 of the Sale and Supply of Alcohol Act 2012 for an On-licence in respect of premises situated at 57-61 Tirau Street, Putaruru, and known as Hog & Hounds Sports Bar.

The applicant is a company incorporated under the Companies Act 1993 on the 27th February 2017.

The applicant has been operating compliantly under a Temporary Authority for 2 months.

The business is an established Tavern.

There will be three certified managers employed.

The applicant seeks the following hours:

- Sunday to Wednesday 10:00am to 10:00pm
- Thursday to Saturday 10:00am 1:00am (the following day)

The application was publicly notified in the South Waikato News on the 24th & 31st of May 2017.

The police initially opposed the application, and essentially the opposition was based on the suitability of the applicant.

On the 23rd of June 2017 the NZ Police met with the applicant, which resulted in the NZ Police withdrawing their opposition, the scheduled hearing was cancelled.

REASONS FOR THE DECISION

The application is complete and contains all the supporting documents as required under s.100 of the Act, no objection has been received, and any matters of opposition have been resolved.

Currently the South Waikato does not have a Local Alcohol Policy;

The requested hours fall within the national default hours;

The premises appears to fit criteria under the CPTED;

There are no negative records linked to the premises that pertain to noise nuisance past or present;

There are no records pertaining to vandalism past or present in the surrounding areas of the premises, nor are there any directly linked to the premises;

There are no sensitive sites within close proximity to the premises;

The applicant appears to have adequate certified staff to manage the premises;

The premises meets the requirements of the Building Code;

The premises meets the requirements of the Resource Management Act 1991;

The Licensing Inspector does not oppose this application;

The Police do not oppose this application;

The Medical Officer of Health does not oppose the application;

The Fire Risk Management Officer does not oppose this application;

The applicant duly advertised their intention to apply for an On-licence;

The application did not attract any public objections;

Overall the South Waikato District Licensing Committee is satisfied as to the matters to which we must have regard as set out in s.105.

DECISION

The District Licensing Committee Chairperson, acting pursuant to the Sale and Supply of Alcohol Act 2012, **approves** an application by H&H Putāruru Limited for an On-licence (17/ON/017/2017) in respect of premises situated at 57-61 Tirau Street, Putaruru subject to the following conditions:

CONDITIONS


- 1) No alcohol is to be sold on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1.00pm on Anzac Day;
- 2) The following days and hours that alcohol can be sold and consumed on the premises are:

Sunday to Wednesday 10:00am to 10:00pm

Thursday to Saturday 10:00am 1:00am (the following day)
- 3) Drinking water is to be freely available whilst the premises are open for business;
- 4) The following steps must be taken to promote the responsible consumption of alcohol:
 - (i) The licensee must ensure that all staff comply with the host responsibility policy submitted with the application for an on-licence detailing the steps to be taken by the licensee to ensure a safe drinking environment.
- 5) The following steps must be taken to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed:
 - (i) Ensure that no intoxicated persons are allowed to enter or to remain on the premises;
 - (ii) Ensure that no minors are allowed to enter or remain on the premises;
 - (iii) Ensure that appropriate signs are prominently displayed detailing the statutory restrictions on the supply of liquor to minors and intoxicated persons adjacent to every point of sale.
- 6) There must be a properly certificated manager or duly appointed manager on the premises at all times the premises is open for the sale and supply of alcohol;
- 7) A duty manager register pursuant to Section 232 must be kept on the premises and maintained;
- 8) The entire premises is designated "Restricted";

9) The licence is issued for one year upon payment of annual fee.
