IN THE MATTER of the Sale and Supply of Alcohol Act 2012 (The Act)

IN THE MATTER of an application from the Pockets 8 Ball Club pursuant to s138 of the Act for an On-site Special Licence in respect of premises 44 Bridge Street Tokoroa and known as Central Coffee & Wine.

THE APPLICATION

I have before me an application from the Pockets 8 Ball Club for the grant of a Special Licence pursuant to s.138 of the Sale and Supply of Alcohol Act 2012 (The Act) in respect of premises situated at 44 Bridge Street, Tokoroa and known as the Central Coffee & Wine.

The application is for a 21st birthday celebration.

The Inspector has filed a positive report and recommends the grant of the Special Licence subject to conditions.

The New Zealand Police and Medical Officer of Health have not raised any matters of opposition.

DECISION

I am satisfied as to the matters to which I must have regard in s.105 and s.142 of the Act, and I am satisfied that this application meets the Purpose and Object of the Act. Accordingly, I grant the special licence (17/SP/079/2017) which may be issued immediately. Conditions will apply to the licence.

REASONS FOR THE DECISION

The applicant has previously operated Special Licences without incident.

Substantive food and free water will be available throughout the event.

The comprehensive report of the Inspector indicates that the amenity and good order of the locality will not be adversely affected by more than a minor extent.

The application was not required to be publicly notified and no opposition or notice of desire to be heard has been received. Accordingly I deal with the matter on the papers.

Neither the Police nor the Medical Officer of Health raises any matters in opposition.

The South Waikato District Council does not currently have a Local Alcohol Policy.

There is nothing in the application which would suggest that the Applicant will supply alcohol in any way which would be inconsistent with the intention of the Act, or any other relevant legal requirement.

I am satisfied as to the matters to which we must have regard as set out in s. 105 & 142 of the Act.

CONDITIONS

- 1) Alcohol may be sold and supplied under the licence only on the following days and during the following hours:

Date	Event	Start Time	Finish Time
Saturday 8 th of April 2017	21 st birthday - Carlos Paaki	6:00pm	1:00am (the following day)

- 2) The entire premises is "Supervised".
- 3) Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
- 4) The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
- 5) Food must be available for consumption on the premises at all times the premise is open for the sale and supply of alcohol. Food should be actively promoted.
- 6) There must be at least one certified manager on the premises for the duration of the event.
- 7) The licensee must ensure that the special licence is visible to patrons and displayed at the principal entrance on the licensed area.
- 8) The licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises.
- 9) No sale of alcohol is to take place after the designated closing time as stipulated on the licence, that being 1:00am (the following day)
- 10) The entire licensed area is to be vacated within 30 minutes of the bar closing, that being 1:30am (the following day) unless that persons presence is justified such as cleaning up.
