Saturday 2^{nd} December 2017 from 4:30pm — 10:00pm the same day <u>or</u> Sunday 3^{rd} December 2017 from 4:30pm — 10:00pm the same day (if raining on the 2^{nd} December)

Saturday 17th February 2018 from 4:30pm — 11:30pm the same day

- 2. The proposed designation for the event is as follows that the premises are "Undesignated"
- 3. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
- 4. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
- 5. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol.
- 6. The licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises.
- 7. The premises must be vacated within 30 minutes of the stated finishing time unless an individual's presence on the premises is justifiable pursuant to Section 255(4) of the Sale and Supply of Alcohol act 2012.
