The Application

WAWA HOLDINGS LIMITED applies for the renewal of the ON Licence for premises situated at 47 Bridge Street, Tokoroa, known as "**WAWA BISTRO**."

The business is that of a tavern style bistro.

The current days and hours are **Monday to Sunday 8.00am to 1.00am the** following day. No changes are sought.

The hours are within the default national maximum trading hours prescribed under the Act for on licensed premises.

The application was publicly notified in the South Waikato News on the 19th and the 26th February 2020. No public objections were received by the DLC secretariat.

Neither the Police nor the Medical Officer of Health have raised any matters in opposition.

Reasons for the Decision

The Inspector reports that the applicant and is an experienced operator of licensed premises and has certificated managers working in the business.

The whole of the premises is designated as a Supervised Area.

I am satisfied that this activity has not reduced the amenity and good order of the locality by more than a minor extent.

As matter of completeness we grant a waiver for the late filing of this application to renew the licence.

Accordingly, I deal with the matter on the papers.

DECISION

The District Licensing Committee Chairman, acting pursuant to the Sale and Supply of Alcohol Act 2012, approves an application by WAWA HOLDINGS LIMITED for the renewal of the ON Licence for premises situated at 47 Bridge Street, Tokoroa, known as <u>"WAWA BISTRO"</u>, subject to conditions.

We refresh the licence conditions to reflect best practice.

Conditions:

The licence is subject to the conditions listed as follows:

1. Alcohol may be sold or supplied for consumption on the premises only on the following days and hours:

MONDAY TO SUNDAY 08:00am to 01:00am the following day;

person who is on the premises to dine.

- 2. No alcohol is to be sold or supplied on the premises on Good Friday, Easter Sunday, Christmas Day or before 1pm on Anzac Day to any person other than a
- 3. The whole of the premises is designated as a **Supervised Area**;
- 4. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.

- 5. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
- 6. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence or menu variations of a similar range and standard. Menus must be visible, and food should be actively promoted.
- 7. A properly appointed certificated, or Acting or Temporary, manager must be on duty at all times when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises;
- 8. The licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises.
- 9. The Licensee must display:
 - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons.
 - b. At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol.
 - c. A copy of the licence attached to the premises so as to be easily read by persons attending the premises.

The licence is renewed for three (3) years from the expiry of the current licence.
