# BEFORE THE SOUTH WAIKATO DISTRICT LICENSING COMMITTEE

**PUTARURU WEST BOWLING CLUB INCORPORATED** applies for a renewal of the CLUB Licence in respect of premises situated at 92 Arapuni Street, Putaruru and known as "**PUTARURU WEST BOWLING CLUB**".

The applicant seeks to renew the existing licensed days and hours of: **Monday** to **Sunday 8.30am to 9.30pm.** 

The application was publicly notified in the South Waikato News on the 01 June 2022 and no objections were received from the public.

The Club has a good range of food options and low and non-alcoholic beverages available at all times.

Neither the reports of the Police nor that of the Medical Officer of Health raises any matters in opposition and the applicant has not come to the attention of reporting agencies during the renewal period.

### REASONS FOR THE DECISION

Neither the Police nor the Medical Officer of Health have raised any matters in opposition.

The inspector reports that the amenity and good order of the area has not been adversely affected by more than a minor extent. The Club has sound host responsibility practices and operates within their principal purpose.

Overall, I am satisfied as to the matters to which we must have regard as set out in s.131 of the Act.

We approve a waiver for the incorrect applicant name on the public notice.

We refresh the conditions to align with best practice and the new Act.

## **DECISION**

The District Licensing Committee Chairman, acting pursuant to the Sale and Supply of Alcohol Act 2012, **approves** an application by **PUTARURU WEST BOWLING CLUB INCORPORATED** for a renewal of the CLUB Licence in respect of premises situated at 92 Arapuni Street, Putaruru and **known as** "PUTARURU WEST BOWLING CLUB" subject to conditions.

The renewal will be for three years from the expiry of the current licence and a replacement licence is to be issued.

# **Conditions:**

The licence is subject to following conditions:

1. Alcohol may be sold or supplied for consumption on the premises only on the following days and hours:

### Monday to Sunday 8.30am to 9.30pm;

- 2. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
- 3. While the premises are open for the sale and supply of alcohol no BYO alcohol may be consumed on the premises.
- 4. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
- 5. At all times the premises are open for the sale and supply of alcohol a range of substantive food must be readily available. A minimum of three

- types of food should be available. Menus must be visible, and food should be actively promoted.
- 6. The licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises.
- 7. The Licensee must display:
  - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
  - b. A copy of the licence attached to the inside of the premises so as to be easily read by persons using the premises.
