THE APPLICATION

PUTARURU THEATRE PLAYERS INCORPORATED applies for an on-site
Special Licence in respect of premises situated at 35-39 Kensington Street,
Putaruru known as The Plaza Theatre.

The licence is to cover 2 musical productions over the next 6 months. Up to 50
persons are expected to attend the events.

The days and hours sought are:

**From Thursday 19 May 2022 to Sunday 22 May 2022 (inclusive) – 7.30 pm to
11.30 pm – Musical “MOONSHINE”**

**From Thursday 26 May 2022 to Sunday 28 May 2022 (inclusive) – 7.30 pm to
11.30 pm – “MOONSHINE”**

**From Thursday 20 September 2022 to Monday 24 September 2022
(inclusive) – 7.30 pm to 11.30 pm – “THE MOUSETRAP”**

Saturday 2 or 9 October 2021 – 6.30 to 12 midnight

Club night – Fellowship Performance and dinner

**Wednesday 10 November 2021 to Saturday 20 November 2021 (inclusive)
End of year musical.**

Substantive food and low alcohol and non-alcoholic beverages will be available at all times.

A certificated manager will oversee the sale, supply and consumption of alcohol.

THE REASONS FOR THE DECISION

The Inspector has provided a report on the application and believes the application meets the criteria for issue.

A certificated manager will also be overseeing the sale, supply and consumption of alcohol at each event.

Neither the reports of the Police nor that of the Medical Officer of Health raises any matters in opposition.

I am satisfied as to the matters to which we must have regard as set out in s.142 of the Act.

DECISION

The District Licensing Committee, pursuant to the Sale and Supply of Alcohol Act 2012 **grants** the application by **PUTARURU THEATRE PLAYERS INCORPORATED** for an on-site Special Licence in respect of premises situated at 35-39 Kensington Street, Putaruru known as **THE PLAZA THEATRE** subject to conditions.

Conditions:

The licence is subject to the following conditions:

1. Alcohol may be sold and supplied for consumption on the premises only on the following days and hours:

From Thursday 19 May 2022 to Sunday 22 May 2022 (inclusive) – 7.30 pm to 11.30 pm – Musical “MOONSHINE”

From Thursday 26 May 2022 to Sunday 28 May 2022 (inclusive) – 7.30 pm to 11.30 pm – “MOONSHINE”

**From Thursday 20 September 2022 to Monday 24 September 2022 (inclusive)
– 7.30 pm to 11.30 pm – “THE MOUSETRAP”**

2. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
3. A certificated manager must be on duty at all times when the premises are open for the sale and supply of alcohol
4. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence or menu variations of a similar range and standard.
5. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
6. The Licensee must display signage as follows:
 - a. At every point of sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
 - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises; and
 - c. A sign prominently displayed at the premises, which identifies by name the for the time being on duty.
7. The licensee must provide information and advice about forms of transport available to patrons from the licensed premises.
8. No BYO alcohol is to be brought into the events.
