**BEFORE THE SOUTH WAIKATO DISTRICT LICENSING COMMITTEE**

**PUTARURU RUGBY FOOTBALL CLUB INCORPORATED** applies for a  
renewal of the CLUB Licence in respect of premises situated at 6 Nola Street,  
Putaruru and known as **'PUTARURU RFC CLUB'**.

The applicant seeks to renew the existing licensed days and hours of:

<b>Monday to Thursday</b>	<b>5.00pm to 11.00pm</b>
<b>Friday</b>	<b>6.00pm to 1.00am the following day</b>
<b>Saturday</b>	<b>11.00am to 1.00am the following day</b>
<b>Sunday</b>	<b>11.00am to 10.00pm;</b>

The application was publicly notified on the 30<sup>th</sup> of November 2022 and the 7<sup>th</sup> of  
December 2022 and no objections were received from the public.

The Club has a basic range of food options on site and low and non-alcoholic  
beverages available at all times.

Neither the reports of the Police nor that of the Medical Officer of Health raises  
any matters in opposition.

## **REASONS FOR THE DECISION**

Neither the Police nor the Medical Officer of Health have raised any matters in opposition and the Club has not come to the attention of reporting agencies in an adverse way during the renewal period.

The inspector reports that the amenity and good order of the area has not been reduced by more than a minor extent. The Club has sound host responsibility practices and operates within their principal purpose.

We grant a waiver for the minor errors in the hours publicly notified.

Overall, I am satisfied as to the matters to which we must have regard as set out in s.131 of the Act.

## **DECISION**

The District Licensing Committee Chairman, acting pursuant to the Sale and Supply of Alcohol Act 2012, **approves** an application by **PUTARURU RUGBY FOOTBALL CLUB INCORPORATED** for a renewal of the CLUB Licence in respect of premises situated at 6 Nola Street, Putaruru and known as **'PUTARURU RFC CLUB'** subject to conditions.

The renewal will be for three years from the expiry of the current licence and a replacement licence is to be issued.

### **Conditions:**

The licence is subject to following conditions:

1. Alcohol may be sold or supplied for consumption on the premises but only on the following days and hours:

<b>Monday to Thursday</b>	<b>5.00pm to 11.00pm</b>
<b>Friday</b>	<b>6.00pm to 1.00am the following day</b>
<b>Saturday</b>	<b>11.00am to 1.00am the following day</b>
<b>Sunday</b>	<b>11.00am to 10.00pm;</b>

2. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises;
3. While the premises are open for the sale and supply of alcohol no BYO alcohol may be consumed on the premises.

4. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
5. At all times the premises are open for the sale and supply of alcohol a range of substantive food must be readily available. A minimum of three types of food should be available. Menus must be visible, and food should be actively promoted.
6. The licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises.
7. Alcohol can be sold and supplied to guests of members of clubs with which the licensee has an arrangement for reciprocal visiting rights for members
8. The Licensee must display:
  - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
  - b. A copy of the licence attached to the inside of the premises so as to be easily read by persons using the premises.
