## **THE APPLICATION**

Hannah <u>SHAW</u>, on behalf of the LICHFIELD SCHOOL SUPPORT GROUP applies for an on-site Special Licence in respect of premises situated at Kells Lane, RD2, Putaruru known as the **Lichfield School and Community Hall**.

The event is a social occasion to be called the "How Down. Up to "250 persons are expected to attend the event.

The days and hours sought are:

Saturday 16 September 2023 5.30pm to 12.00 midnight.

Substantive food and low alcohol and non-alcoholic beverages will be available at all times.

A certificated manager will oversee the sale, supply and consumption of alcohol.

### THE REASONS FOR THE DECISON

The Inspector has provided a report on the application and believes the application meets the criteria for issue.

A certificated manager will also be overseeing the sale, supply and consumption of alcohol at the event.

Neither the reports of the Police nor that of the Medical Officer of Health raises any matters in opposition.

By agreement additional potential discretionary conditions have been negotiated with the applicant by the MOoH.

The principal activity of the event will be other than the sale, supply and consumption of alcohol and any additional restrictive conditions are largely unnecessary.

However, the applicant appears happy to comply and we have incorporated them into the licence.

Subject to the above, I am satisfied as to the matters to which we must have regard as set out in s.142 of the Act.

#### DECISION

The District Licensing Committee, pursuant to the Sale and Supply of Alcohol Act 2012 grants the application by Hannah <u>SHAW</u>, on behalf of the LICHFIELD SCHOOL SUPPORT GROUP for an on-site Special Licence in respect of premises situated at Kells Lane, RD2, Putaruru known as the <u>Lichfield School and Community Hall</u> subject to conditions.

## **Conditions:**

The licence is subject to the following conditions:

- 1. Alcohol may be sold and supplied for consumption on the premises only on the following days and hours:
  - Saturday 16 September 2023 5.30pm to 12.00 midnight (sales to cease at 11.30pm);
- 2. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises;

- 3. A certificated manager must be on duty at all times when the premises are open for the sale and supply of alcohol;
- 4. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence or menu variations of a similar range and standard;
- 5. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages;
- 6. The Licensee must display signage as follows:
  - a. At every point-of-sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
  - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises; and
  - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty.
- 7. The licensee must provide information and advice about forms of transport available to patrons from the licensed premises including the courtesy van.
- 8. No BYO alcohol is to be brought into the event.
- 9. The whole of the premises is designated as a Restricted Area.
- 10. Maximum service size of 2 drinks per person per sale is permitted from 10.30pm.
